WHEREAS, More than fifty percent (50%) of the owners of real property abutting upon the Street Improvement District for the paving of alleys have heretofore filed herein their Petition asking that certain alleys be improved with cement pavement, and

WHEREAS, Said Petition was approved by the Council of the City of Lebanon and thereafter by the Works Progress Administration on the 30th day of August, 1938, and

WHEREAS, The City Engineer made and filed with the City of Lebanon plans, specifications, and estimates for the paving of said alleys, which plans, specifications, and estimates were approved by the Council,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That the cost of the construction of said paving which is to be borne by the property especially benefitted thereby and abutting thereon is the sum of

That the proportionate share of the cost of said improvement to be borne by the real property abutting thereon and benefitted thereby and to be assessed thereon is hereby ascertained and declared to be the amounts set immediately after the separate description of each of said lots or tracts of land, and each of said lots or tracts of land is determined and declared to be benefitted by said improvement in the sum equal to or greater than the amount assessed as follows, to-wit:


