ORDINANCE BILL NO. 2 FOR 1939

ORDINANCE NO. 505

WHEREAS, More than fifty (50) percent of the owners of the real property abutting upon said Street Improvement District heretofore filed herein their Petition asking that said Alley be improved with cement pavement, and

WHEREAS, Said improvement was ordered by the Common Council of the City of Lebanon after complying with the provisions of the Charter of said City, and

WHEREAS, Said improvement was made and is now completed,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That the cost of the construction of the said paving which is to be borne by the property abutting thereon and especially benefitted thereby is the sum of Four Hundred Fifty Nine and 50/100 dollars (\$459.50)

Section 2. That the proportionate share of the cost of said improvement to be borne by the real property abutting thereon and especially benefitted thereby and to be assessed therefor is hereby ascertained and declared to be the amounts set immediately after the separate descriptions of the lots or tracts of land hereafter described, and each of said lots or tracts of land is determined and declared to be benefitted by said improvement in the sum equal to or greater than the amount assessed thereto as follows, to-wit:

Scott Chrisman Motor Co:

All of Lot One (1) and the North forty-nine (49)
feet of Lot Two (2) in Block Three (3), William
Ralston's Addition, being 121 feet on the Alley.

Number of feet: 121

Assessment: \$ 102.85

Michael Schenk:

The South seventeen (17) feet of Lot Two (2)
and all of Lot Three (3) in Block Three (3)
William Ralston's Addition, being 83 feet on the
Alley.

Number of feet: 83 Assessment: \$ 70.55

O & C and Southern Pacific Railroads:

All of Lot Four (4) and all of Lot Eight (8)
in Block Three (3) William Ralston's Addition,
being 132 feet on the Alley.

Number of feet: 132 Assessment: \$ 112.20

Walter Scott:

All of Lot Seven (7) in Block Three (3)
William Ralston's Addition, being 66 feet on
the Alley.

Number of feet: 66 Assessment: \$ 56.10

W. L. Grove:

All of Lot Six (6) in Block Three (3),
William Ralston's Addition, being 66 feet
on the Alley.

Number of feet: 66 Assessment: \$ 56.10


Rose Pickens:

All of Lot Five (5) in Block Three (3),
William Ralston's Addition, being 72 feet
on the Alley.

Number of feet: 72 Assessment: \$ 61.20

Section 3. That the Recorder of the City of Lebanon
is hereby ordered and directed to immediately enter a state-
ment of the assessments made and declared by this Ordinance,
together with the names of the respective owners of such
lots and tracts of land hereinabove described, in the Docket
of City Liens of said City of Lebanon, as provided by the
Charter of said City, and to give notice of said assessment
as provided by said Charter.
