ORDINANCE BILL NO. 7 FOR 1939
ORDINANCE NO. 510

A BILL FOR AN ORDINANCE TO LICENSE, TAX AND REGULATE ROOMS AND PLACES WHERE GAMES WITH PLAYING CARDS ARE OPERATED WITHIN THE CITY OF LEBANON, OREGON, AND PROVIDING A PENALTY FOR VIOLATION HEREOF.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That the owner, proprietor or keeper of any room or place within the City of Lebanon where card games are operated or conducted shall pay to the City of Lebanon a quarterly license fee of Two and 50/100 Dollars (\$2.50) for each table belonging to or used in the room or place to be licensed.

Section 2. The owner or keeper of any room or place within the City of Lebanon licensed to operate games of cards therein shall close said room or place within the hours of twelve o'clock midnight and six o'clock in the morning and at all hours upon the first day of the week commonly called Sunday.

Section 3. No person being the owner of keeper of any room or place wherein cards are played under the provisions of this Ordinance shall be permitted to allow or permit any minor to visit, loiter around or frequent such room or place or to play at any game therein.

Section 4. All card rooms within the meaning of this
Ordinance shall be located upon the first or ground floor
and no such rooms or places shall be permitted to be operated
within any basement or upon any second or other floors of
any building and shall be in buildings open to the public.
No owner, proprietor or keeper of any such rooms so licensed
shall suffer or permit any games of any character to be
played therein where money, or representation of money, or

any form of gambling is involved, provided, that any game played for trade checks, commonly called "hickies", representing a value not to exceed five cents  $(5\phi)$  per person per game, shall not be prohibited under the provisions of this Ordinance.

Section 5. Any person violating any of the provisions of this Ordinance, upon conviction thereof in the Recorder's Court, shall be punished by a fine of not less than Ten and No/100 Dollars (\$10.00) nor more than Fifty and No/100 Dollars (\$50.00), or by imprisonment in the City Jail for not less than five (5), nor more than twenty-five (25) days, or by both such fine and imprisonment, at the discretion of the Court, and, in addition thereto, the Court may, at its discretion, revoke or suspend the license of any such person; provided that upon a second conviction of the violation of any of the terms of this Ordinance, it shall be mandatory upon the part of the Court to permanently revoke such license.

Passed by the Council and approved by the Mayor this 5th day of July, 1939.
