ORDINANCE NO. 515

A BILL FOR AN ORDINANCE TO AMEND ORDINANCE NO. 507, OF THE CITY OF LEBANON, LINN COUNTY, OREGON.

WHEREAS, The owners of all of the premises abutting upon the total abutting upon Ash Street between the first alley East of Main Street and Park Street have filed herein their petition asking that said street be paved to a width of forty-four (44) feet instead of thirty-two (32) feet, as provided by the plans and specifications heretofore filed by the City Engineer and approved and ordered built by an ordinance duly and regularly passed by the Council and approved by the Mayor, and have agreed to pay the additional cost thereof above and in addition to the cost of the 32-foot street as advertised in the notice given in accordance with the provisions of the City Charter, and have jointly and severally waived notice of change of said plans and specifications, irregularity in the procedure for widening said paving, and of the right of remonstrance, and have confirmed all proceedings and acts of the City necessary to secure the widening of said paving to forty-four (44) feet,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON, OREGON, DO ORDAIN AS FOLLOWS:

Section 1. That Ordinance No. 507, of the City of

Lebanon, Oregon, passed by the Council and approved by the Mayor on the 7th day of March, 1939, be and the same is hereby amended to order the improvement of Ash Street between the first alley East of Main Street to Park Street by paving the same to a width of forty-four (44) feet.

Section 2. That said improvement, being in a district where traffic is congested and a wider street is necessary to accommodate such traffic and parking of automobiles, said improvement is hereby declared to be necessary and proper and for the best interests of the people of the City of Lebanon and of special benefit to the property abutting thereon.

Section 3. That the paving of the streets in the above described improvement district having progressed to a point where the above mentioned portion of said street improvement district should be the next paving to be undertaken and can be done most economically by starting work thereon immediately, this ordinance, therefore, is necessary for the peace, health, and safety of the people of the City of Lebanon and an emergency is hereby declared, and this ordinance shall be in full force and effect upon its passage by the Council and approval by the Mayor.

Passed by the Council and approved by the Mayor this 20th day of August, 1940.
