

ORDINANCE BILL NO. 11 FOR 1941

ORDINANCE NO. 530

A BILL FOR AN ORDINANCE DECLARING A STREET IMPROVEMENT DISTRICT, FOR ORDERING THE IMPROVEMENT THEREOF, AND PROVIDING FOR THE TIME AND MANNER IN WHICH SAID IMPROVEMENT SHALL BE DONE.

WHEREAS, The owners of more than fifty per cent of the real property abutting upon Rose Street between the West line of Second Street and the East line of Third Street in the City of Lebanon, Linn County, Oregon, have heretofore filed their petition asking for the improvement of said portion of Rose Street and by constructing the necessary headers and curbs, the property owners to pay a portion of the cost thereof and the remainder of said cost to be paid by a grant of funds from the Federal Government; and

WHEREAS, By Resolution No. 4 for 1941, passed by the Council and approved by the Mayor of said City on the 21st day of January, 1941, the Council did thereafter call for plans, specifications and estimates of said improvement and of the cost thereof, and thereafter in accordance with the order of the said Council the City Engineer did prepare and file plans, specifications and estimates, which were thereafter approved, ratified and affirmed by Resolution No. 5 for 1941, passed by the Council and approved by the Mayor on the 21st day of January, 1941; and

WHEREAS, The Common Council did thereafter give notice of its intention to make said improvements by posting notices thereof, in accordance with the provisions of the Charter of the said City of Lebanon, in five public places in said City for a period of ten days, and the time for remonstrances having elapsed and no remonstrances against said improvement having been filed, and less than 6 months having elapsed since the posting of said notice, and it appearing unto the Council that said improvements should be made.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORLAIN AS FOLLOWS:

Section 1. That the above described Street Improvement District and the jurisdiction of the Council thereover to make said improvement are hereby established and declared; that the City of Lebanon shall make said improvement under the direction of the City Engineer and he shall proceed forthwith to pave the street in said Improvement District in accordance with the provisions of the Charter of the City of Lebanon and in the manner provided by the specifications heretofore made by him and to construct headers and curbs wherever the same shall be necessary and pursue said construction and improvement to completion at the earliest possible date.

Section 2. That the City Engineer shall keep an accurate account of the total cost of said improvement and the proportion thereof to be borne by each separate lot or tract of land abutting thereon and report the same to the Council and upon completion thereof report any variance from the cost heretofore estimated by him.

Section 3. That this being an ordinance concerning the improvement of a street, the same is ~~being~~ deemed a work of necessity and for the peace, health and safety of said City and shall be in full force and effect from and after its passage by the Council and approval by the Mayor of said City.
