ORDINANCE BILL NO. 17 FOR 1941 ORDINANCE NO.5 3 6

A BILL FOR AN ORDINANCE DECLARING A CURB IMPROVEMENT DISTRICT, FOR ORDERING THE IMPROVEMENT THEREOF, AND PROVIDING FOR THE TIME AND MANNER IN WHICH SAID IMPROVEMENT SHALL BE DONE.

WHEREAS, The City Council of the City of Lebanon, Linn County, Oregon, did by Resolution No. 16 for 1941, passed by said Council and approved by the Mayor of said City upon the 1st day of April, 1941, find it to be necessary and desirable and for the best interests of said City that there be constructed curbs along both the East and the West sides of Main Street from the North line of Academy Street to the South line of Wheeler Street in the said City of Lebanon, Linn County, Oregon, and did further declare that such improvement can at this time be accomplished with a cost to the owners of the property benefitted thereby of only the cost of the necessary materials, the cost of the labor being paid by a great of Federal funds to the said City of Lebanon, and did by said Resolution require the City Engineer to prepare plans, specifications and estimates of said proposed improvement and of the cost thereof; and

WHEREAS, in accordance with said Resolution, the said City Engineer did duly prepare such plans, specifications and estimates, which were thereafter approved, ratified and affirmed by Resolution No. 17 for 1941, passed by said Council and approved by said Mayor on the 1st day of April, 1941; and

WHEREAS, The Common Council did thereafter give notice of its intention to make said improvements by posting notices thereof, in accordance with the provisions of the Charter of the said
City of Lebanon, in five public places in said City for a period
of ten days, and the time for remonstrances having elapsed and no
remonstrances against said improvements having been filed, and less
than six months having elapsed since the posting of said notice,
and it appearing unto the Council that said improvements should be
made.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

ment District and the jurisdiction of the Council thereover to make said improvements are hereby established and declared; that the City of Lebanon shall make said improvements under the direction of the City Engineer and he shall proceed forthwith to construct the curbs in said Improvement District in accordance with the provisions of the Charter of the City of Lebanon and in the manner provided by the specifications heretofore made by him and pursue said construction and improvements to completion at the earliest possible date.

Section 2. That the City Engineer shall keep an accurate account of the total cost of said improvements and the proportion thereof to be borne by each separate lot or tract of land sbutting thereon and report the same to the Council and upon completion thereof report any variance from the cost heretofore estimated by him.

Section 3. That this being an ordinance concerning the improvements of curbs within said City and thus being deemed and considered that the same is a work of necessity and required by the peace, health and safety of said City and an emergency therefore existing, this ordinance shall be in full force and effect from and after its passage by the Council and approval by the Mayor of said City.
