

ORDINANCE BILL NO. 9 FOR 1943

ORDINANCE NO. 591 ✓

AN ORDINANCE CALLING A SPECIAL ELECTION AND SUBMITTING TO THE VOTERS AT THE ELECTION A PROPOSITION THAT THE CITY OF LEBANON LEVY TAXES UNDER AUTHORITY OF CHAPTER 4, TITLE 97, O. C. L. A. 1940 FOR THE PURPOSE OF FINANCING THE REPLACEMENT, REPAIR, AND CONSTRUCTION OF THE SEWER SYSTEM, AND THE CONSTRUCTION OF A DRAINAGE SYSTEM FOR THE CITY OF LEBANON, AND DECLARING AN EMERGENCY.

WHEREAS Chapter 4, Title 97, O.C.L.A. 1940 authorizes cities and towns to levy taxes for the purpose of providing in advance sinking funds for financing the construction, reconstruction, improvement, betterment and repair of public works projects; and

WHEREAS the Council of the City of Lebanon desires to provide in advance a sinking fund for the purpose of financing the replacement, repair, and construction of the sewer system and the construction of a drainage system for the City of Lebanon,

THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

SECTION 1. That a special election shall be held in the City of Lebanon on the 21st day of May, 1943.


SECTION 2. That the following proposition shall be submitted to the voters at said election:

During the fiscal years 1943-44, 1944-45, 1945-46, 1946-47, and 1947-48, the City of Lebanon shall levy taxes in accordance with Chapter 4, Title 97, O.C.L.A. 1940, for the purpose of providing in advance a sinking fund for financing the replacement, repair, and construction of the sewer system and the construction of a drainage system for the City of Lebanon, estimated to cost Seventy Thousand Dollars (\$70,000.00), and these taxes shall be outside the limitation on taxation appearing in Article XI, Section 11 of the Constitution of Oregon.

SECTION 3. In as much as the sewer system of the City

of Lebanon has become badly in disrepair and inadequate to properly handle the sewage of the City and no adequate provision has heretofore been made for drainage of surface water from the City of Lebanon, unsanitary conditions have been caused thereby, including the backwater of sewage and flooding upon the ground, in many basements, and under houses, and immediate steps should be taken to improve said unsanitary and unsafe conditions, this Ordinance is for the peace, health and safety of the people of the City of Lebanon, and an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect upon its passage by the Council and approval by the Mayor.

SPECIAL ELECTION NOTICE

NOTICE IS HEREBY GIVEN that pursuant to Ordinance Bill No. 9 for 1943, passed by the Common Council and approved by the Mayor of the City of Lebanon, County of Linn, State of Oregon, on the 6th day of April, 1943, a SPECIAL ELECTION will be held in said city on Friday, the 21st day of May, 1943, for the purpose of submitting to the legal voters of said City of Lebanon, for their approval or rejection, the following proposition:

"DURING THE FISCAL YEARS 1943-44, 1944-45, 1945-46, 1946-47, 1947-48, the City of Lebanon shall levy taxes in accordance with Chapter 4, Title 97, O.C.L.A. 1940, for the purpose of providing in advance a sinking fund for financing the replacement, repair, and construction of the sewer system and the construction of a drainage system for the City of Lebanon, estimated to cost Seventy Thousand Dollars (\$70,000.00), and these taxes shall be outside the limitation on taxation appearing in Article XI, Section 11 of the Constitution of Oregon."

That said Special Election will be held, commencing at 8:00 A.M. and continuing until 8:00 P.M. of said day.

That the polling places for said election in the several precincts of the City will be the same as in the last general election as follows:

First Precinct, in the sales room of the Scott-Chrisman Motor Company, Main and Oak Streets in said city.

Second Precinct, in the sales room of the Kirkpatrick Motor Company, Second and Sherman Streets in said city.

Third Precinct, in the High School gymnasium on the campus of the high school of Linn County School District No. 16, in said City.

Fourth precinct, in the basement of the Methodist church, corner of Vine and Park Streets in said city.

Fifth precinct, on the first floor of the I.O.O.F. lodge building at the corner of Main and Ash streets in said city.

Sixth precinct, in the Girl Scout's building, on the southwest corner of the Queen Anne school of Linn County school district No. 16, in said city.
