ORDINANCE NO. 600

AN ORDINANCE ADOPTING SURVEYOR'S REPORT FOR THE WIDENING OF A PORTION OF MILTON STREET.


WHEREAS the City Council has heretofore ordered G. E. Whitcomb, who is a competent surveyor, to make a survey of Milton Street from Main Street East to the West line of Home Addition for the purpose of determining the description of said street and the private land to be appropriated in widening said portion of said street from a twenty (20) foot street to a forty (40) foot street; and

WHEREAS said surveyor has made a plat thereof and the description of the boundaries of said portion of said street as, if and when widened to be a forty foot street, and the descriptions of the parcels of private property to be appropriated in the widening of said portion of said street, all of which are on file with the Recorder of the City of Lebanon, copies of which are attached hereto and made a part hereof,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

SECTION 1. That said survey, report and plat be and each thereof is hereby approved.

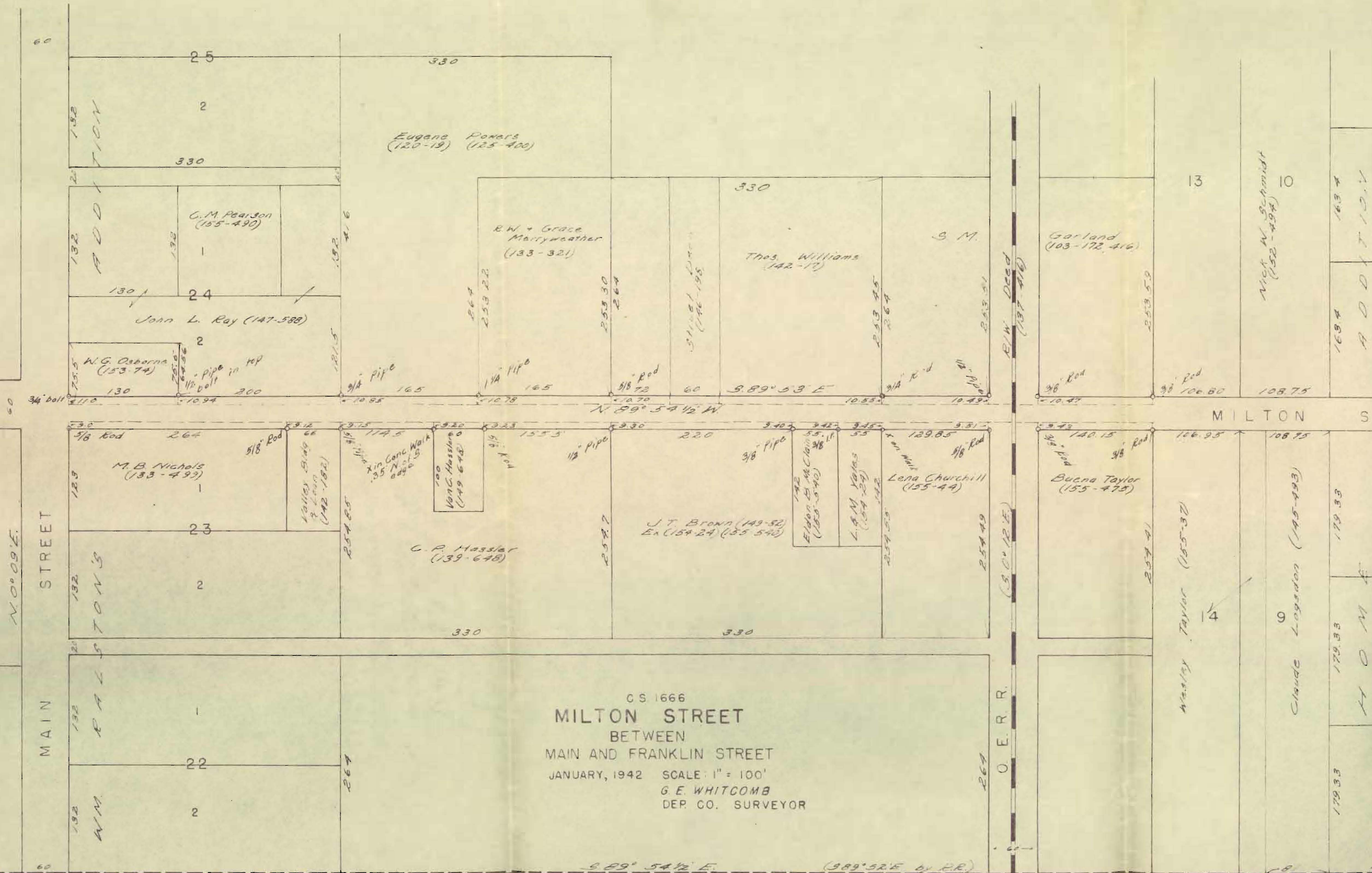

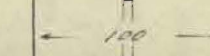

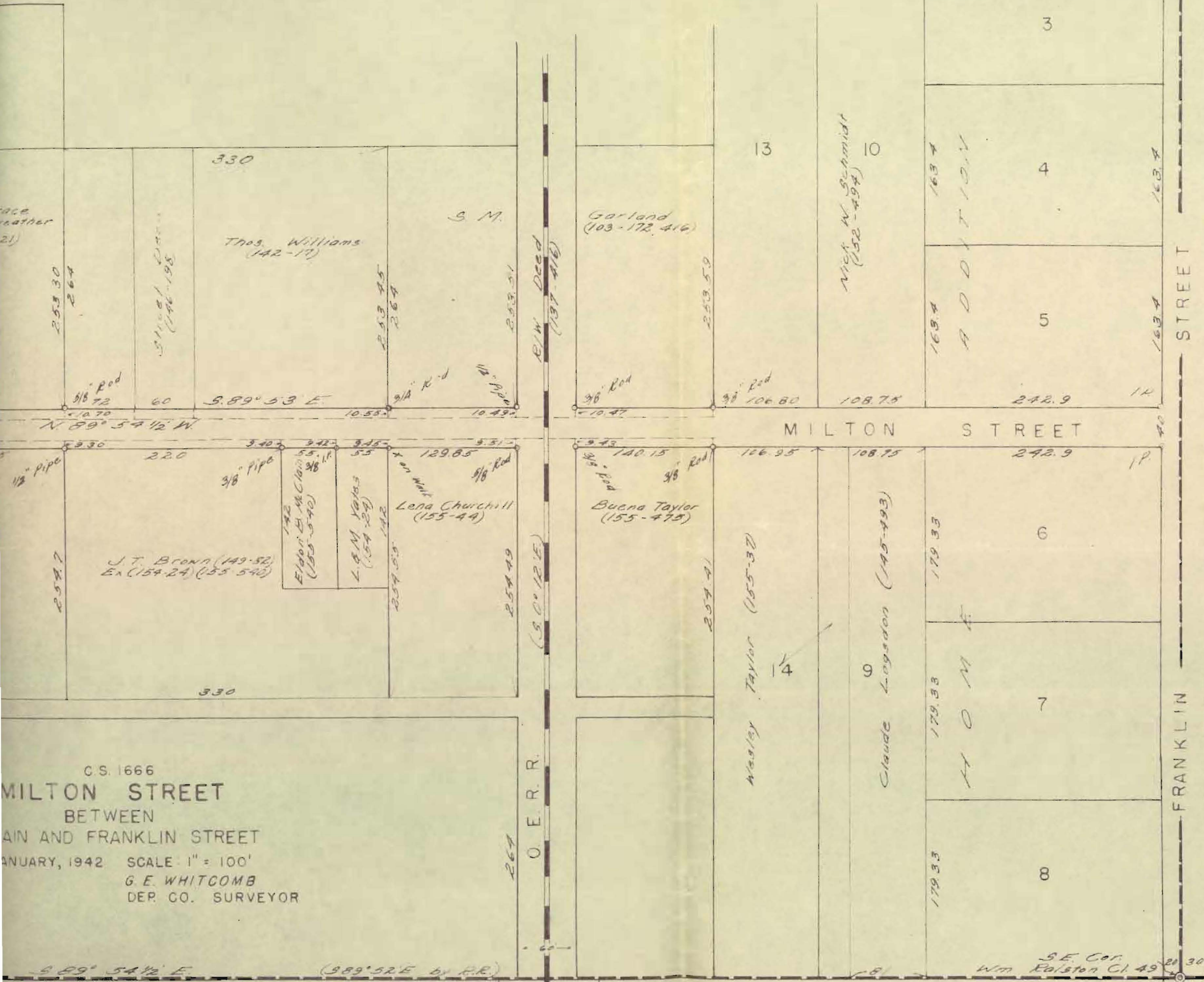
