

ORDINANCE BILL NO. 11 FOR 1944

ORDINANCE NO. 616

AN ORDINANCE CALLING FOR A SPECIAL ELECTION TO BE HELD NOVEMBER 7, 1944, AND SUBMITTING TO THE VOTERS AT SUCH ELECTION A PROPOSITION THAT THE CITY OF LEBANON LEVY TAXES UNDER AUTHORITY OF CHAPTER 4, TITLE 97, O.C.L.A. 1940 FOR THE PURPOSE OF FINANCING THE CONSTRUCTION OF A STREET EQUIPMENT BUILDING, THE CONSTRUCTION OF A FIRE HALL, AND THE REMODELING OF THE CITY HALL, AND DECLARING AN EMERGENCY.

WHEREAS Chapter 4, Title 97, O.C.L.A. 1940 authorizes cities and towns to levy taxes for the purpose of providing in advance sinking funds for financing the reconstruction, improvement, betterment, repair and rehabilitation of public buildings and public works, projects; and

WHEREAS the Council of the City of Lebanon believes it advisable to provide in advance a sinking fund for the purpose of financing the reconstruction, improvement, betterment, repair and rehabilitation of certain public buildings for the City of Lebanon; and

WHEREAS the Council believes that it will be necessary to expend approximately Twenty-five Thousand Dollars (\$25,000.00) for said construction work, and that a tax of five (5) mills on all the taxable property in the city for three (3) fiscal years will be required to raise said sum;

THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

SECTION 1. That a special election shall be held in the City of Lebanon at the same time as the State General Election on November 7, 1944.

SECTION 2. That the following proposition shall be submitted to the voters at said election:

During the fiscal years 1945-46, 1946-47, and 1947-48, the City of Lebanon shall levy taxes of five (5) mills on all the taxable property in said city in accordance with Chapter 4, Title 97, O.C.L.A. 1940 for the purpose of providing in advance a sinking fund of approximately Twenty-five Thousand Dollars (\$25,000.00) for the construction of a street equipment building, for the construction of a fire hall, and for remodeling the city hall, and these taxes shall be outside the limitation imposed by Article XI, Section 11 of the Constitution of Oregon.


SECTION 3. In as much as it is necessary to provide housing for the city's street and fire equipment and to remodel the city hall and it is necessary to provide funds now for said expenditures, and the election at which the foregoing proposition is proposed to be voted upon is less than sixty (60) days away, this ordinance is necessary for the peace, health and safety of the people of the City of Lebanon, and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage by the Council and approval by the Mayor.

Passed by the Council and approved by the Mayor this 19th day of September, 1944.
