AN ORDINANCE VACATING RAILROAD STREET FROM THE NORTH LINE OF LOT ONE, A. P. MORRIS'S ADDITION, TO THE SOUTH LINE OF TANGENT STREET.

WHEREAS, W. H. McDonald and W. L. Barnes have petitioned the Common Council for an ordinance vacating Railroad Street from the North Line of Lot One, A. P. Morris's Addition, to the South line of Tangent Street, a distance of approximately six hundred (600) feet, and

WHEREAS, the Southern Pacific Railroad Company, through its superintendent, has consented to the vacation of said portion of said street, and

WHEREAS, the Petitioners McDonald and Barnes are the owners of all the real property abutting upon the West side of said street, and the said Railroad Company is the owner of the railroad right of way abutting on the East side of said portion of said street, and

WHEREAS, the residents and property owners abutting upon said street South of the portion thereof proposed to be vacated have means of egress to their premises over the portion of said street not effected by this vacation, and have seldom used the portion of said street proposed to be vacated, which, by virtue of its width of twenty-one (21) feet, is of little use as a street, and

IT APPEARS, THEREFORE, that the public will not be inconvenienced by the vacation thereof.

NOW, THEREFORE, the people of the City of Lebanon do ordain as follows:

SECTION 1. That all of the property owners abutting upon said portion of said street proposed to be vacated, having joined in the request for the vacation thereof, no notice of vacation is required, and such notice need not be given,

SECTION 2. That Railroad Street, from the North line of Lot One, A. P. Morris's Addition, to the South Line of Tangent Street, be and the same is hereby vacated.

SECTION 3. That the portion of said street hereby vacated, being for the benefit and use of the Petitioners, who employ a great number of men and will add the payroll of this city and vicinity; this ordinance is for the peace, health and safety of the people of the City of Lebanon, and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after it is passed by the Council and approved by the Mayor.
