

ORDINANCE BILL NO. 17 for 1947  
ORDINANCE NO. 649

AN ORDINANCE ORDERING THE CONSTRUCTION OF  
REGULATION CURBINGS.

The people of the City of Lebanon do ordain  
as follows:

Section 1. That a regulation curb be constructed  
on the North side of Carolina Street, in front of the follow-  
ing described real property owned by CECIL G. MASON:

Beginning at a point on the East side of  
Main Street which is 60 feet North of the  
Northwest corner of Block 1 of Kirkpatrick  
Addition to Lebanon, Oregon; and running  
thence East on the North line of Carolina  
Street 447.916 feet; thence North 92 feet  
to the Cemetery Grounds; thence West 447.916  
feet to Main Street; thence South 92 feet to  
the place of beginning.

Section 2. That regulation curbs be constructed  
on Park Street, in front of the following described premises  
owned or reputedly owned by the persons whose names appear  
on each description:

Johnson, Ida M. (140-118)

Lots 5 and 6 in Block 4, Kirkpatrick's Addition  
to the Town of Lebanon, Linn County, Oregon.

Stegman, Fred H. & Ione E. (184-469)

Lot 7 in Block 4, Kirkpatrick's Add to Lebanon.

Young, Boyde & Neva (140-37)

Lot 8, Block 4, Kirkpatrick's Add to Lebanon.

Powell, A.M. & V.M. (151-68)

Lots 3 and 4 in Block 3, except the South 60  
feet of Lot 4, Kirkpatrick's Addition to Lebanon.

Stringer, C.D. & Zelda (183-429)

The South 60 feet of Lot 4, Block 3, Kirkpatrick's  
Addition to Lebanon.

Porter A.L. & Laura A. (159-86)

Lot 3 in Block 1, Cowan's Addition to Lebanon.

Fitzgerald, Elmer & M.J. (152-319)

Beginning at the Southeast corner of Lot 2, in Block 2, Kirkpatrick's Addition to the City of Lebanon; thence South 66 feet; thence West 159 feet; thence North 66 feet; thence East 159 feet to the place of beginning, containing  $\frac{1}{4}$  acre.

Thietje, Louis O. & Helen M. (169-751)

Beginning at a point on the West side of Park Street in Lebanon, Lin<sup>n</sup> County, Oregon, which is 126 feet North of the Northeast corner of Lot 2 in Block 14 in Ralston's 3rd Add. to the town of Lebanon and running thence North along the West line of Park Street 66 feet; thence West parallel with the North line of said Lot 2, 159 feet; thence South 66 feet; thence East to the place of beginning, containing a fraction of an acre, in Lebanon, Oregon.

Ball, Oren G. & Jennie M. (179-817)

Beginning 66 feet North of the Northeast corner of Block 14, Ralston's 3rd Add to the town of Lebanon; thence North 60 feet; thence West 159 feet; thence South 60 feet; thence East 159 feet to the place of beginning.

Muetz, W.B. (154-178)

The East 89 feet of the South half of the Southeast quarter of Block 1, Kirkpatrick's Addition to Lebanon.

Section 3. That each lot and parcel of land herein-  
above described is hereby declared to be benefitted in the  
amount of the cost of said improvement abutting upon the  
same, and shall bear the cost thereof; that the City En-  
gineer is hereby ordered to prepare plans and specificat-  
ions for said improvement, together with an estimate of the  
work to be done and the cost thereof, and file the same in  
the office of the Recorder.

Section 4. That the Recorder is hereby directed to cause to be given notice of intention to make said improvements in the manner provided by Charter.

This Ordinance being necessary for the peace, health, and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect after its passage by the Council.
