ORDINANCE NO. 654

AN ORDINANCE CALLING A SPECIAL ELECTION ON MAY 21,1948.

THE PROPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:-

Section 1. That there shall be submitted to the voters of the City of Lebanon, for their approval or rejection, at an election to be held in said City on the Sth day of May, 1948, the following proposition:

That there shall be levied against all taxable property within the corporate limits of the City of Lebanon, Oregon, a special tax of five (5) mills, for the fiscal year 1948-49 to and including the fiscal year 1952-53, which shall be outside the six (6) per cent limitation, as provided by Article XI, Section 11 of the Constitution of Oregon, for the purpose of providing funds for the construction, replacement, maintenance, and repair, of city streets and bridges.

Section 2. That the ballot title for the ballot shall be as follows:

That there shall be levied against all taxable property within the corporate limits of the City of Lebanon, Oregon, a special tax of five (5) mills, for the fiscal year 1948-49 to and including the fiscal year 1952-53, which shall be outside the six (6) per cent limitation as provided by Article XI, Section 11, of the Constitution of Oregon, for the purpose of providing funds for the construction, replacement, maintenance, and repair, of city streets and bridges.

Section 5. That there shall also be submitted to the voters, for their approval or rejection at said election the following proposition:-

That there shall be levied against all taxable property within the corporate limits of the City of Lebanon, Oregon, a special tax of five (5) mills, for the fiscal year 1948-49 to and including the fiscal year 1952-53, which shall be outside the six (6) per cent limitation as provided Article XI, Section 11, of the Constitution of Oregon, for the purpose of

of constructing a sewage disposal plant and facilities in connection therewith.

Section 4. That the ballot title for the ballot shall read as follows:-

That there shall be levied against all taxable property within the corporate limits of the City of Lebanon, Oregon, a special tax of five (5) mills, for the fiscal year 1948-49 to and including the fiscal year 1952-53, which shall be outside the six (6) per cent limitation as provided by Article XI, Section 11, of the Constitution of Oregon, for the purpose of providing funds for the construction of a sewage disposal plant and facilities in connection therewith.

Section 5. That the City Recorder is hereby authorized and instructed to publish notice of said election in the manner provided by law.

Section 6. That the following polling places for said election are designated:
