ORDINANCE BILL NO. 29 FOR 1949 ORDINANCE NO. 709

A BILL FOR AN ORDINANCE TAKING JURISDICTION OF THE PROPOSED IMPROVEMENT, ORDERING THE SAME TO BE DONE BY CONTRACT TO BE AWARDED TO THE LOWEST RESPONSIBLE BIDDER AND DIRECTING THE CITY RECORDER TO PUBLISH NOTICE INVITING PROPOSALS FOR BIDS.

WHEREAS, more than 50 per cent of the onwers of all of the real property abutting upon Milton Street from Main Street to Williams Street and on Williams Street from Milton Street to Grant Street and signed and filed with the City Recorder a petition requesting that the paving of and construction of curbing be made upon said streets and

WHEREAS, pursuant to the request contained in said petition the City Counciler-has created two improvement districts, one on Milton Street from Main Street to Williams Street and the other on Williams Street from Milton Streetoto Grant Street, and has entered into a contract with the State Highway Commission whereby a portion of the cost of said improvement shall be borne by the State of Oregon with the understanding that the contract to do the work shall be let to the lowest responsible bidder and

WHEREAS, plans, specifications and estimates of the cost of said improvements prepared by engineers employed by the State Highway Commission have been filed with the City Recorder of the City of Lebanon, and approved by the City Engineer of the City of Lebanon; and notice of intention to make said improvement has been published in the manner provided by the Charter of the City of Lebanon, and

WHEREAS, the time for filing remonstrance against the proposed street improvement has elapsed and no remonstrance have been made or filed herein.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON, DO ORDAIN AS FOLLOWS: That the Council does hereby take jurisdiction of said proposed improvement and orders that the same shall be done by contract to be awarded to the lowest responsible bidder with the right of the City to reject any, and all bids.

II.

That the Recorder is hereby ordered to publish for ten (10) days in a newspaper published in Lebanon, Oregon, a notice inviting proposals for the making of such street improvements referring to the plans and specifications therefor filed in his office, and the time when said work shall be completed.

III.

That said work shall commence not later than July 20, 1949 and shall be completed not later than

IV.

That said work shall be done in the manner provided by the plans and specifications heretofore filed by the City Engineer and approved by the Council; and the contractor shall be subject to the penalties for default or failure to complete said work in the manner and within the time provided in his contract with the City, and shall indemnify the City by a bond in an appropriate amount with a surety or sureties approved by the Council for the faithful and prompt performance of said contract, and for the payment of damage s for the failure thereof in the sum or sums provided in said contract.
