Beginning at the intersection of the center line of Franklin Street and the center line of Milton Street and running thence East along the center line of Milton Street to the Northeast corner of Walnut Park Addition, thence South along the East line of Walnut Park Addition to the Southeast corner of said addition, thence West along the South line of said addition to a point which is East 75 feet from the East line of Franklin Street, thence South 80 feet, thence West to the center line of Franklin Street, thence North along the center line of Franklin Street to the place of beginning. A BILL FOR AN ORDINANCE TAKING JURSIDICTION OF THE PROPOSED DRAINAGE DISTRICT ABOVE DESCRIBED, KNOWN AS DRAINAGE DISTRICT NUMBER SEVEN, AND ORBERING RECORDER TO PUBLISH NOTICE INVITING PROPOSALS FOR THE CONSTRUCTION OF DRAINS, AND DECLARING AN EMERGENCY:

WHEREAS, By Resolution No. 21 for 1950, passed by the Council and approved by the Mayor on the 22nd day of May, 1950, the Council declared the above described area to be a drainage district, and

WHEREAS, the ^City Engineer has made and filed plans, specifications and estimates for the drainage of said a **ze** a which were approved and adopted by said Resolution, and

WHEREAS, the City Recorder has caused notice of intention of the City to make said improvements, and the time for publication thereof, as prescribed by the Charter has elapsed and no reconstrance thereto have been made or filed herein,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

I.

That the Council does hereby take jurisdiction of said proposed improvement and orders that the same shall be done by contract to be awarded to the lowest responsible bidder with the right of the City to reject any, and all bids;

II.

That the Recorder is hereby ordered to publish for ten (10) days in a newspaper published in Lebanon, Gregon, a notice inviting proposals for the construction of said drains referring to the plans and specifications and estimates therefore filed in her office.

III.

That said work shall commence not later than July 25, 1950 and shall be completed not later than thirty days thereafter.

IV.

That said work shall be done in the manner provided by the plans and specifications heretofore filed by the City Engineer and approved by the Council; and the Contractor shall be subject to the penalties for default for failure to complete said work in the manner and within the time provided in his contract with the City, and shall indemnify the City by a bond in an appropriate amount with a surety or sureties approved by the Council for the faithful and prompt performance of said contract, and for the payment of damages for the failure thereof in the sum or sums provided in said contract.

V.

It hereby is adjudged and declared that existing conditions are such that this ordinance is necessary for the immediately preservation of the public peace, health and safety of the people of the City of Lebanon; and an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage.
