DEVICES FOR CARRYING ON BUSINESS OR COMMERCIAL
AMUSEMENT AND REPEALING ORDINANCE NO. 585, 628,
643, 677, 678, 679, 745, 897, and 901.

ORDINANCE NO. 909

The people of the city of Lebanon do ordain as follows:

Section 1. GENERAL REQUIREMENT AND EXCEPTIONS. No person shall engage in a business or occupation or operate a device mentioned in the schedule of fees in this ordinance unless he first obtain from the city a license to do so. The requirements of this ordinance shall not apply, however, to activities carried on for religious, educational or charitable purposes.

Section 2. PENALTY. Any person who violates this ordinance shall be subject to a fine not more than \$200 or to imprisonment in the city jail not more than 100 days or to both.

Section 3. RECORD OF LICENSES: The recorder shall keep a record of licenses in a well-bound book, which shall be spaced in six columns to contain the following information:

Column 1. The name of the applicant for a license.

Column 2. The date of granting the license.

Column 3. The occupation or business for which the license is granted.

Column 4. The time for which the license is granted.

Column 5. The amount that is paid for the license.

Section 4. CONTENT OF LICENSE. A license granted under this ordinance shall state the name of the license, the date of issue of the license, the duration of the license, the nature of the activity of device licensed, the amount of fee paid for the license, and the location of the activity or device licensed if it has a fixed location.

Section 5. RESTRICTIONS ON RIGHTS CONFERRED BY LICENSE. No license shall be transferable without consent of the council.

No licensed activity or device with a fixed location shall be changed to another location within the city unless the council first approve the change of location.

Section 6. MANNER OF GRANTING. A person applying for a license required by this ordinance shall fill out an application blank furnished by the recorder and pay the recorder the required fee, and upon doing so shall be entitled to the license.

Section 7. DURATION OF LICENSE. The duration of a license shall be determined according to the fee schedule in this ordinance and the amount of fee which the licensee pays at the time of procuring the license.

Section 8. Each applicant for license required by this ordinance shall pay a fee for the license according to the following fee schedule:

Section 9. REVOCATION OF LICENSE. If a licensee, in exercising a privilege conferred by a license required by this ordinance, violates an ordinance of the city, the city council, after giving him notice of and opportunity for hearing on contemplated revocation of the license because of the violation, may revoke the license.

Section 10. NUMBER OF CARNIVALS RESTRICTED. The recorder shall not license more than one carnival to operate in the city at one time.

Section 11. PLUMBER'S BOND. Every person, before obtaining a plumber's license, shall file with the recorder a good and sufficient bond to be approved by the council, in the penal sum of \$1000, and payable to the city of Lebanon, conditioned that the principal in the bond will faithfully observe all the ordinances of the said city pertaining to plumbing and house drainage; that he will indemnify the city for and save it harmless from any accident or damages caused by any neglect or negligence in his work as plumber or by the unfaithful or inadequate work done by himself or his employee as plumber; that he will restore all sidewalks, cross walks, pavements, and streets torn up or disturbed by him or his employees, and replace them in as good condition as they were before being disturbed; and that he will properly guard and protect all openings during the progress of such work, and save the city harmless against any accident or damages from the openings.

Section 12. This Ordinance expressly repeals Ordinance No. 585, 628, 643, 677, 678, 679, 745, 897, and 901.

Section 13. That it being necessary to regulate and provide for the licensing of said businesses, this Ordinance is necessary for the peace, safety and general welfare for the people of the City of Lebanon, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage by the Council and approval by the Mayor.
