ORDINANCE NO. 924

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That hereafter the voting precincts of the City of Lebanon, Oregon, shall be as follows:

- Precinct No. 1. Beginning at the southwest corner of the city limits of Lebanon, Oregon, and running thence north to the center of Grant Street; thence east to the center of Main Street; thence south down the center of Main Street to the south city limits; thence following in a westerly direction the city limits line to the place of beginning.
- Precinct No. 2. Beginning at the intersection of Rose Street with Main Street; thence running west down the center of Rose Street to the west city limits; thence south along the city limits line to the center of Grant Street; thence east down the center of Grant Street to the center of Main Street; thence North along the center of Main Street to the place of beginning.
- Precinct No. 3. Beginning at the intersection of Main and Rose Streets, and running thence north along the center line of Main Street and Highway 20 to the north city limits; thence west along said city limits to the northwest corner of the city limits; thence south along the west line of the city limits to the center of Rose Street; thence east along the center line of Rose Street to the place of beginning.
- Precinct No. 4. Beginning at the Northeast corner of the City limits of Lebanon, Oregon, and running thence West to the center of Highway 20; thence South along the center of Highway 20 and Main Street to the center of the intersection of Main and Vine Streets; thence East along the center of East Vine Street to the center of the intersection of Williams Street and East Vine Street; thence North along the center of Williams Street to the center of the intersection of Williams Street and Wheeler Street; thence East down the center of Wheeler Street to the East City limits; thence in a Northerly direction along the City limits line of Lebanon, Oregon to the place of beginning.
- Precinct No. 5. Beginning in the center of the intersection of Main and Vine Streets; thence South down the center of main Street to the center of the intersection of Main Street and East Grant Street; thence Easterly down the center of Grant Street to the East line of the City limits of Lebanon; thence North along the East line of the City limits to a point that is due East of the center line of East Vine Street; thence West to Vine Street and continuing in a Westerly direction down the center of Vine Street to the place of beginning.

Precinct No. 6. Beginning at the center of Intersection of East Grant Street and Main Streets and running thence South along the center of Main Street to the center of the intersection of Main Street and Elmore Street; thence East down the center of Elmore Street and East beyond the end of Elmore Street to the East line of the City limits of Lebanon; thence North along the East line of the City limits to the center of East Grant Street; thence in a Westerly direction along the center of Grant Street to the place of beginning.

Precinct No. 7. Beginning at the center of the intersection of Elmore Street and Main Street; thence South along the center of Main Street to the South city limits of the City of Lebanon; thence in a general Easterly direction along the Southerly line of the City limits of Lebanon to the center of the Oregon Electric Railway; thence North down the center of the Oregon Electric Railway track to the intersection of Elmore Street and Williams Street; thence West down the center of Elmore Street to the place of beginning.

Precinct No. 8. Beginning at the Southeast corner of the City limits of Lebanon; thence in a general Westerly direction along said City limits line to the center of the Oregon Electric Railway track; thence North down the center of the Oregon Electric Railway track to the intersection of Elmore Street and Williams Street; thence East down the center of Elmore Street and continuing East beyond the East end of Elmore Street to the East line of the City limits of Lebanon; thence South along the East line of the City limits of Lebanon to the place of beginning.

Precinct No. 9. Beginning at the center of the intersection of East Vine Street and Williams Street; thence East to the East line of the City limits of Lebanon; thence in a Northerly and Northwesterly direction along the present City limits of the City of Lebanon to the center of Wheeler Street; thence West down the center of Wheeler Street to the center of the intersection of Wheeler and Williams Street; thence South along the center line of Williams Street to the place of beginning.

Section 2. That hereafter the wards of the City of Lebanon, Oregon, shall be as follows:

Ward #1 - shall include the areas of Precincts numbered 1 and 2.

Ward #2 - shall include the areas of Precincts numbered 3, 4 and 9.

Ward #3 - shall include the area of the Precincts numbered 5, 6, 7, and 8.

Section 3. Ordinance No. 563, passed by the Council and approved by the Mayor on the 15th day of September, 1942, be and hereby is repealed.

Section 4. That inasmuch as there will be a special election held within the City of Lebanon on the 17th day of December, 1955, for the purpose of determining the annexation of certain property to the City of Lebanon and there has been a change in the Precincts since the last general election within the City of Lebanon, and this Ordinance is necessary to avoid confusion, therefore, it being necessary to preserve the peace, health and safety of the City of Lebanon, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.

Passed by the Council and approved by the Mayor on this 6th day of December, 1955.
