

A BILL FOR AN ORDINANCE TO ANNEX
CERTAIN REAL PROPERTY TO THE CITY
OF LEBANON, AND DISPENSING WITH AN
ELECTION WITHIN THE CITY LIMITS

ORDINANCE BILL NO. 3
for 1956

ORDINANCE NO. 928

WHEREAS, pursuant to an ordinance passed by the Common Council of the City of Lebanon on the 20th day of December, 1955, notices were published and posted in the City of Lebanon, Oregon, in compliance with Sections 222.110 to 222.190, inclusive, of Oregon Revised Statutes, and a hearing was held by the Common Council at 8:00 o'clock P.M., January 17, 1956, in the Council Chambers, City Hall, Lebanon, Linn County, Oregon, at which persons were permitted to appear and be heard on the question of the annexation to the City of Lebanon of the real property herein described, and

WHEREAS, the Common Council has now carefully considered the matter,

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That the following described real property, to-wit:


Beginning at the intersection of (a line which is parallel to and South 255.75 feet from the North line of the L.T. Woodward D.L.C. No. 45) with the present Easterly boundary of the City of Lebanon; and running thence East along first said line to the Southwesterly line of the land formerly conveyed to O'Neil Brothers and Callaghan Company by deed recorded in Book 72 on page 342 of Deed Records for Linn County, thence Southeasterly along said line of said conveyance to the Southwest corner thereof, thence East along the South line of said land and said line produced East to the center of the Albany - Santiam Canal, thence Southeasterly along the center of said canal to the Northeast corner of Santiam Street and Kirkpatrick's Third Addition to Lebanon, thence West along the North line of said addition to the original Easterly boundary of the City of Lebanon, thence Northwesterly along said boundary to the place of beginning.

shall be annexed to the City of Lebanon, Oregon, and become a part thereof, provided and upon the condition that a majority of the votes cast in an election to be held within said described area shall be in favor of annexation, or provided that one hundred per cent of the owners of the real property above described shall sign a consent and file same with the Recorder of the City of Lebanon, consenting to said annexation without an election. That no election upon said annexation shall be held within the City of Lebanon

Section 2. That this ordinance shall be subject to referendum.

Section 3. That this ordinance, the election to be held within the area to be annexed or the consent of the owners of the property in the area to be annexed, and all other proceedings appertaining thereto, shall be governed by Sections 222.110 to 222.190, inclusive, of Oregon Revised Statutes.
