WHEREAS, plans, specifications and contract documents have heretofore been submitted to the Common Council by the firm of Cornell, Howland, Hayes and Merryfield, 1600 Western Avenue, Corvallis, Oregon, for the secondary clarifier and other additions to the existing sewage treatment plant, and

WHEREAS, said plans, specifications and contract documents have heretofore been approved by the Common Council, now therefore,

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

That the Recorder of the City of Lebanon is hereby authorized and directed to publish an advertisement for bids in substantially the following form:

Sealed proposals for the construction of Additions to the Sewage Treatment Plant, addressed to the City of Lebanon, Lebanon, Oregon, will be received at the office of the City Recorder, Lebanon, Oregon, until 4:00 P. M. Pacific Standard Time on 3rd day of May 1957, and then publicly opened and read.

The work contemplated consists of the construction of Additions to the Sewage Treatment Plant to provide a final clarifier and other minor items of construction. The major item of construction is a 55-foot diameter circular clarifier. Other items include revision and additions to the sludge piping system, installation of an underground irrigation system, construction of a concrete masonry pump house, changes to the existing chlorination system, change to existing plant by-pass outfall line and the construction of concrete walkways.

The work will be awarded to the responsible bidder submitting the lowest acceptable bid.

Plans, Specifications, Information for Bidders, and Contract Forms may be examined at the office of the City Recorder, Lebanon, Oregon, or in the office of Cornell, Howland, Hayes and Merryfield, 1600 Western Avenue, Corvallis, Oregon. Single copies of said Documents may be obtained at the above offices upon a deposit of Twenty Dollars (\$20.00). The full amount of the deposit will be refunded if said Documents are returned in good condition within fifteen (15) days after the bid opening. Additional copies of said Documents may be obtained from the above offices upon a deposit of Twenty Dollars (\$20.00) for each additional copy. Ten Dollars (\$10.00) will be refunded if said additional copies of the Documents are returned in good condition within fifteen (15) days after the bid opening.

Bidders must be prequalified in accordance with the Laws of Oregon.

Each proposal must be submitted on the prescribed form and accompanied by a certified check, cashier's check, or bid bond payable to the City of Lebanon, Lebanon, Oregon, in an amount not less than five (5) per cent of the amount bid.

The successful bidder will be required to furnish security for faithful performance of the Contract in the full amount of the Contract price. The right is reserved to reject any and all proposals, to postpone the award of the Contract for a period not to exceed thirty (30) days, and to accept such proposals as are to the best interests of the City of Lebanon.
