THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section (1) That the Mayor and the Recorder are hereby
authorized and directed to enter into a contract with W. Glenn
Huston and Willa E. Huston, and said contract to be in words
and figures substantially as follows:



CONTRACT

KNOW ALL MEN BY THESE PRESENTS, that the CITY OF LEBANON, a municipal corporation, hereinafter referred to as "CITY", and W. GLENN HUSTON and WILLIA E. HUSTON, husband and wife, hereinafter referred to as "HUSTON", and

WHEREAS, Huston is the owner of certain real property abutting upon West Grant Street commencing at the Northeast corner of Lot 5, Block 2, City of Lebanon and running thence East 96 feet, and

WHEREAS, the widening of said street would especially benefit the property owned by said Huston, now therefore, the parties agree as follows:

WITNESSETH:

The City shall widen said street on the South side thereof on the portion abutting the above described real property, a distance of 96 feet.

City shall pay the cost of relocating the curb, drainage and resurfacing the existing street and Huston shall pay for the surfacing and base of the extra width of said street which shall be surfaced and based according to the specifications of the City of Lebanon which have heretofore been setup by the Common Council for a standard city street. Immediately upon the completion of said street widening, Huston agrees to pay to the City of Lebanon the actual cost of said paving and base, plus 10% for engineering.

IN WITNESS WHEREOF, the City has executed this agreement by and through its Recorder and Mayor, pursuant to Ordinance heretofore duly adopted and Huston have executed this agreement of their own free will on this 27th day of May, 1957.
