SUPPLEMENT TO
LEBANON RURAL FIRE PROTECTION DISTRICT
CONTRACT

WHEREAS, on the 29th day of June, 1956, the City of Lebanon, a municipal corporation, therein and herein called "FIRST PARTY", and the Lebanon Rural Fire Protection District, a municipal corporation, therein and herein called "SECOND PARTY", did enter into a contract with each other for fire protection by the First Party to the Second Party, and

WHEREAS, the Second Party has entered into a contract with the City of Sodaville, a municipal corporation, and has heretofore been obtaining the assessment for fire protection from the City of Sodaville, and has in turn been paying same to the First Party herein for fire protection for the incorporated limits of the City of Sodaville, now therefore, the parties agree that the aforementioned contract of June 29, 1956, be, and hereby is, amended to include, in addition to the area covered by the Lebanon Rural Fire Protection, but also to extend fire protection to the City of Sodaville on the same terms and conditions as to the Lebanon Rural Fire Protection District under the terms of the aforementioned contract.
