THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section (1) That the Mayor and the Recorder of the City of Lebanon be directed to accept a Deed from L. E. Arnold and Clara P. Arnold of the following described real property located in the City of Lebanon and donated to the City of Lebanon, Oregon, for street purposes, to-wit:

Beginning at a point on the East line of South Fifth Street, said point being South 105.00 feet from the Southwest corner of Lot 5, Block 6, Supplemental Plat No. 2 of Blocks 52 to 61 inclusive in Hyland Addition, Lebanon, Oregon; and running thence Easterly parallel to the South line of said addition 330.00 feet to the West line (produced South) of Fourth Street, thence South along said street line 50.00 feet, thence Westerly parallel to the South line of Hyland Addition 330.00 feet to the East line of Fifth Street, thence North along said street line 50.00 feet to the place of beginning, the land herein conveyed being for street purposes.

ALSO: Beginning at a point on the East line of South Fifth Street, said point being South 366.10 feet from the Southwest corner of Lot 5, Block 6, Supplemental Plat No. 2 of Blocks 52 to 61 inclusive in Hyland Addition, Lebanon, Oregon; and running thence Easterly parallel to the South line of said addition 330.00 feet to the West line (produced South) of Fourth Street, thence South along said street line 50.00 feet, thence Westerly parallel to the South line of Hyland Addition 330.00 feet to the East line of Fifth Street, thence North along said street line 50.00 feet to the place of beginning, the land herein conveyed being for street purposes.

ALSO: Beginning at a 1" Iron pipe on the East line of South Fifth Street, said Iron pipe being South 626.10 feet from the Southwest corner of Lot 5, Block 6, Supplemental Plat No. 2 of Blocks 52 to 61 inclusive in Hyland Addition, Lebanon, Oregon; and running thence Easterly 160.00 feet to a point (from which point a 3/4" Iron rod bears West 10.00 feet), thence South parallel to Fifth Street 60.00 feet, thence West 160.00 feet to a 1" Iron pipe on the East line of Fifth Street, thence North along said street line 60.00 feet to the place of beginning, the land herein conveyed being for street purposes.

Section (2) Whereas, the aforementioned described real property is now being used for street purposes, it is necessary for the public health, safety and welfare that this Ordinance Bill become effective immediately and an emergency is hereby declared.

Passed by the Council and approved by the Mayor this 10th day of October, 1959.
