## CONTRACT

THIS CONTRACT made and entered into this day of 1960, between the WESTERN STATES FIRE APPARATUS of Cornelius, Oregon, hereinafter called the "MANUFACTURER" and the CITY OF LEBANON of Lebanon, Linn County, Oregon, hereinafter called the "BUYER".

## WITNESSETH:

1. The Manufacturer agrees to make and sell to the Buyer and the Buyer agrees to buy from the Manufacturer a 750 GPM, Class "A" triple combination pumper, booster tank, hose body, and equipment as set forth in the detailed specifications included in the invitation for bids attached hereto and in accordance with the bids submitted by the Manufacturer on March 8, 1960, attached and installed on a F 950 Ford chassis furnished by the Lebanon Motor Company, Lebanon, One on Oregon.

2. The completed unit will be delivered F.O.B. Lebanon Fire Station, tested and approved by the National Board of Fire Underwriters in the Oregon Insurance Rating Bureau. An experienced engineer furnished by the Manufacturer will at time of delivery instruct and train the operating firemen of the Buyer in the use and care of the apparatus until they are competent in its use.

3. The agreed price of the equipment set forth in the attached detailed specifications will be \$16,260.18, less the sum of \$223.37, for the 50 ampere Leece-Neville alternate, and less the sum of \$102.80, for the use of 9" tires, and less the sum of \$412.00 for freight for a total contract price of \$15,522.01. Payment to be made upon delivery and acceptance of the equipment by the City of Lebanon.

4. The Manufacturer agrees to delivery the unit within ninety (90) working days after receipt of the chassis at the manufacturing plant at Cornelius, Oregon.
