THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. Ordinance No. 924 shall be amended by the addition of the following section, which shall read as follows:

" Section 4. The following premises shall be known as 'Ordinance No. 1160 Annexed Tract'.

AREA # 1

Lots 1, 2, 12 and the East 3 feet of lot 11, Block 5 Mountain View Additions

All of Block 2 Mountain View Addition.

AREA # 3

Lots 7, 8, 9, 10, 11, & 12 Penny Addition.

AREA # 4

Beginning at the Inforsection of the West line of the Lebenon City Limits and the South line of Lot 12 Penny Addition and running thence West to the East line of Nichols Addition; thence north slong the East time of Nichols Addition to the Southsest corner of Lot 3, Block 3 of said addition; thence West to the Southwest corner of Lot 6, Block 2 of Michals Addition; thence South along the East line of Tenth Street to a point on the East line of Tenth Street, said point being 60 feet East of the Northeest corner of the Seventh Day Adventist Church and School premises; thence West to the Northwest corner of the Seventh Day Adventist Church and School premises; thence South along the West line of said premises to the North line of Block I Green Acres Addition; Thence West to the East line of Twelfth Street; thence South to the North line of Maple Street; thence East to the West line of Tenth Street; thence North to a point 60 feet North of the Northeast corner of Black I Green Acres Addition; thence East across Tenth Street and along the North Line of Sherman Street a dist of 607,22 feet; thence North to the North line of Ash Street; thence East along the North line of Ash Street to the West line of the Lebanon City Limits; thence North along said City Limit line to the South line of Vine Street; thence West along the South line of Vine Street 575 feet more of less to a point 151.2 feet South of the Southwest corner of Hunt's Addition; thence North 151.2 feet to the Southwest corner of said Hunt's Addition; thence North along the West line of Addition Hunt's Addition to the Northwest corner of said Addition; thence East along the North line of Munt's Addition to the West line of the Lebanon City Limits; thence North along the West City Limit line to the place of beginning. AREA # 5

Beginning at the Northwest corner of Block 48 Hyland Addition and running thence South to the Southwest corner of said Block 48; thence East along the South line of said Addition to a point 16.76 feet West of the West line of Block 5! Hyland Addition; thence North along a line parallel to and 16.76 feet West of the West line of said Block 5! to a point on the South line of F. Street If projected East firm the West line of Block 48 Hyland Addition; thence East to the West line of the Lebenon City Li Its; thence North along said City Limit line to the South line of E Street; thence West along the South line of E street to the place of beginning.

Section 5. Precinct No. 10 shall include that Area #5 of the above Ordinance No. 1160 Annexed Tract.

Section 6. Precinct No. 2 shall include all of Area #4 of Ordinance No. 1160 Annexed Tract, which lies South of West Rose Street.

Section 7. Precinct #3 shall include Area #1, Area #2, Area #3, and all of Area #4, lying North of West Rose Street, of Ordinance No. 1160 Annexed Tract."

Section 2. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
