A BILL FOR AN ORDINANCE CALLING A SPECIAL ELECTION ON JUNE 20, 1966, SUBMITTING TO THE LEGAL ELECTORS: (1) A PROPOSITION AUTHORIZ A PROPOSITION AUTHORIZING A LEVY BY THE CITY OF LEBANON OF A TAX IN THE SUM OF \$69,076.00 OUTSIDE THE CONSTITUTIONAL LIMITATIONS, FOR PURPOSE OF PROVIDING AND USING FUNDS FOR THE OPERATION AND MAINTENANCE OF ALL DEPARTMENTS OF THE GENERAL FUND; and (2) A PROPOSITION AUTHORIZING A SPECIAL LEVY BY THE CITY OF LEBANON OF A TAX IN THE SUM OF \$6,000.00 OUTSIDE THE CONSTITUTIONAL LIMITATIONS, FOR THE PURPOSE OF PROVIDING AND USING FUNDS FOR THE PURCHASE OF FIRE TRUCKS; and (3) A PROPOSITION AUTHORIZING A SPECIAL LEVY BY THE CITY OF LEBANON OF A TAX IN THE SUM OF \$13,500.00 OUTSIDE THE CONSTITUTIONAL LIMITATIONS, FOR THE PURPOSE OF PROVIDING AND USING FUNDS FOR THE IMPROVEMENT AND DEVELOPMENT OF AND PURCHASE OF EQUIPMENT FOR CITY PARKS, AND DECLARING AN EMERGENCY.

ORDINANCE BILL NO. 9 for 1966

ORDINANCE NO. 1209

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

<u>Section 1.</u> That a special election be held in the City of Lebanon, Linn County, Oregon, on the 20th day of June, 1966, between the hours of 8:00 o'clock A.M. and 8:00 o'clock P.M. for the purpose of submitting proposed tax levies in excess of the 6% constitutional limitation which is now on file in the office of the Recorder of the City of Lebanon, which have been proposed by the Common Council by Resolution heretofore unanimously passed and more specifically set forth as follows:

Ι.

<u>Section 1.</u> That the proposition to be printed on the ballot shall be as follows:

A proposition submitted to the legal electors of the City of Lebanon by its Common Council at a special election to be held on June 20, 1966, for a tax in the sum of \$69,076.00, outside the constitutional 6% limitation, for the fiscal tax year 1966-67, for the purpose of providing funds for the operation and maintenance of the General Government Department, Communications Department, Policy Department, Fire Department, Public Property Department, Dog Control Department, Park Department, Library Department, Street Lights and Water Department, Municipal Court Department and Special Expenditures Department, which are all departments in the general fund, and for all or any one or combination of such purposes. <u>Section 2.</u> That the text and ballot title for the proposition shall be as follows:

Shall the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$69,076.00 for the purpose of providing and using funds for the operation and maintenance of all departments of the general fund, against all taxable property within the limits of said City, outside the constitutional 6% limitation of the State of Oregon, for the fiscal tax year 1966-67.

II.

<u>Section 1.</u> That the proposition to be printed on the ballot shall be as follows:

A proposition submitted to the legal electors of the City of Lebanon by its Common Council at a special election to be held on June 20, 1966, for a tax in the sum of \$6,000.00, outside the constitutional 6% limitation, for each of the two tax years beginning with the fiscal tax year 1966-67 and ending with the fiscal tax year 1967-68, for the purpose of providing funds for the purchase of fire trucks, and expenses incident thereto.

Section 2. That the text and ballot title for the

proposition shall be as follows:

Shall the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$6,000.00 for the purpose of providing and using funds for the purchase of fire trucks, against all taxable property within the limits of said City, outside the constitutional 6% limitation of the State of Oregon, for two tax years beginning with the fiscal tax year 1966-67 and ending with the fiscal tax year 1967-68.

III.

<u>Section 1.</u> That the proposition to be printed on the ballot shall be as follows:

A proposition submitted to the legal electors of the City of Lebanon by its Common Councul at a special election to be held on June 20, 1966, for a tax in the sum of \$13,500.00, outside the constitutional 6% limitation, for the fiscal tax year 1966-67, for the purpose of providing and using funds for the improvement and development of and the purchase of equipment for City Parks, and expenses incident thereto. <u>Section 2.</u> That the text and ballot title for the proposition shall be as follows:

Shall the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$13,500.00 for the purpose of providing and using funds for the improvement and development of and purchase of equipment for City Parks, against all taxable property within the limits of said City, outside the constitutional 6% limitation of the State of Oregon, for the fiscal tax year 1966-67.

IV.

<u>Section 1.</u> That said proposal for special levies be placed on the official ballot by the City Recorder to be voted on by the legal electors of the City of Lebanon at said election.

<u>Section 2.</u> That the Recorder of the City of Lebanon is hereby authorized and directed to publish and post notices of said election in the manner provided by law.

<u>Section 3.</u> That the polling places for said election in the City of Lebanon shall be as follows:

Section 4_{\bullet} That the Clerks and Judges of said election shall be as follows:

<u>Section 5.</u> That the polling places for said election shall be open from the hour of 8:00 o'clock A.M. to 8:00 o'clock P.M., on said day and that the Chief of Police is instructed to place polling booths, pens, pencils and ballots for the purpose of providing for said election and the Recorder is directed to provide poll books therefor.
