THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. Section 1 of Ordinance No. 1139 is amended to
read as follows:

All acts which are made unlawful by the above mentioned sections of the state laws shall be considered as offenses against the City of Lebanon and a violation of this ordinance when committed within its boundaries, and are punishable by the penalties hereinafter provided, which shall, for the purpose of this ordinance, supersede all other penalties.

Section 2. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
