AN ORDINANCE CALLING FOR A SPECIAL ELECTION ON JANUARY 10, 1967, SUBMITTING TO THE REGISTERED VOTERS OF THE TERRITORY PROPOSED FOR ANNEXATION, THE QUESTION OF WHETHER OR NOT SAID TERRITORY SHOULD BE ANNEXED BY ALTERING THE BOUNDARIES OF THE CITY OF LEBANON TO INCLUDE SAID TERRITORY, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 1231

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS: <u>Section 1.</u> That there shall be submitted to the registered voters residing in the territory hereinafter described for their approval or rejection at a special election to be held in the territory proposed to be annexed, on the 10th day of January, 1967, the following proposition:

> SHALL THE FOLLOWING DESCRIBED TERRITORY BE ADDED TO THE CITY OF LEBANON:

Beginning at a point on the East side of Franklin Street and the existing limits of the City of Lebanon; thence South easterly along the East line of Franklin Street and River Road to a point which is N.67°12'E of the South end of Fuller Lane; thence South Westerly along a line bearing S.67°12'W to the West line of the Oregon Electric Railway right-of-way; thence South easterly along the West line of said Railway right-of-way to a point 150 feet South of the South line of Gilbert Street; thence West along a line which is 150 feet South of and parallel to the South line of Gilbert Street to a point which is 150 feet Easterly at right angles to U.S. Highway 20; thence Southeasterly along a line which is 150 feet Easterly and parallel to U.S. Highway 20, to the West line of the Oregon Electric right of way; thence Southeasterly along said right of way to a point due North of the West line of Sturtevant Road; thence South to a point on the West line of Sturtevant Road which is 150 feet Southerly at right angles to U.S. Highway 20; thence Northwesterly along a line 150 feet Southerly and parallel to U.S. Highway 20 to a point 150 feet South of Crowfoot Road; thence Westerly along a line 150 feet South of and parallel to said Crowfoot Road to a projected point 150 feet West of South Main Road; thence North along a line 150 feet West of and parallel to South Main Road to a point 150 feet South of Vaughn Lane; thence West along a line 150 feet South of and parallel to Vaughn Lane to a point due South of the West boundary line of that tract of land designated as ownership No, 6000 on Linn County Assessor's Map 12-2W-22A; thence North across Vaughn Lane and along the West boundary line of said tract of land to the South line of the First Addition to South Cedar Subdivision; thence West and North along the boundary line of said First Addition to South Cedar Subdivision and the West boundary line of Rothman Subdivision to the South line of Harmony Subdivision ; thence West along the South boundary line of Harmony Subdivision and said line projected West to the intersection of the East line of 12th Street projected South; thence North along said projected 12th Street line to a point 150 feet North of Airport Road on the East line of 12th Street; thence Easterly along a line 150 feet North of and parallel to Airport Road to the existing West boundary line of the City of Lebanon on the East side of 7th Street; thence Easterly along existing City limit lines to the place of beginning.

ANNEXATION OF TERRITORY PROPOSED BY ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LEBANON, OREGON, AND REFERRED TO THE REGISTERED VOTERS OF THE TERRITORY TO BE ANNEXED.

<u>Section 3.</u> That the proposition to be printed on the ballot shall be as follows:

SHALL THE ABOVE DESCRIBED TERRITORY BE ANNEXED TO THE CITY OF LEBANON, OREGON?

<u>Section 4.</u> That the City Recorder is hereby authorized and directed to publish and post notices of said election in the manner provided by law, and in particular ORS 222.130.

<u>Section 5.</u> That the polling places, judges and clerks for said election within the territory proposed to be annexed shall be as follows:

Section 6. That the polling places for said election shall be open from the hour of 8:00 o'clock A.M. to 8:00 o'clock P.M. of said day; that the Chief of Police is instructed to place polling booths, pens, pencils, and ballots for the purpose of providing for said election, and the Recorder is directed to provide poll books therefor.

<u>Section 7.</u> WHEREAS, if the City of Lebanon is going to provide services for the proposed territory to be annexed within the near buture, it is necessary that the election called for in this ^Ordinance be held at the earliest possible date, therefore, being required for the peace, health and safety of the City, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage by the Council and approval by the Mayor.
