ORDINANCE NO. 1244

WHEREAS a public hearing was held as provided in Ordinance No. 1243, pursuant to the provisions of ORS 222.120; and

WHEREAS, as provided in ORS 222.170, at least two-thirds of the landowners of the following described property:

Lots 1 and 2, Supplemental Plat of Blocks 16 to 19, inclusive, A. F. BAHRKE'S FRUITDALE ADDITION to the City of Lebanon, Linn County, Oregon; and

Beginning at a point on the South line of E Street and the existing boundary line of the City limits of Lebanon; thence North 60 feet to the Northwest corner of the intersection of 9th Street and E Street; thence West along the north line of E Street a distance of 495.50 feet; thence North 438 feet to the Northwest corner of that tract of land shown as Tax Lot No. 2500 on Linn County Assessor's Map 12-2W-15BA; thence East along the North line of said tract of land, across 9th Street, and along the North line of those tracts of land shown as Tax Lots No. 2700, 2800 and 2900 on said Assessor's map, a distance of approximately 1,150 feet, to the existing west boundary line of the City of Lebanon; thence South and West along said City limit boundary line to the place of beginning, all in HYLAND ADDITION,

who also own at least two-thirds of the land in the contiguous territory and of real property therein, representing at least two-thirds of the assessed value of all real property in the contiguous territory, have, prior to the public hearing, consented in writing to the annexation and have filed a statement of their consent with the City Council; and

WHEREAS said real property is contiguous territory to the City of Lebanon,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That said territory is hereby declared to be



annexed to the City of Lebanon, and the City Recorder is hereby directed to make and submit to the Secretary of the State of Oregon a copy of this Ordinance, together with a copy of the statement of consent of the landowners in said territory, and also a copy of the Ordinance declaring that no election shall be required within the City of Lebanon.

Section 2. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
