ORDINANCE NO. 1268

WHEREAS there has been filed with the City of Lebanon a written Petition for the annexation of the area described below; and

WHEREAS the City Charter of the City of Lebanon does not expressly prohibit the City from dispensing with submitting the question of annexation to the registered voters of the City; and

WHEREAS, pursuant to the provisions of ORS 222.120, the City Council has elected to dispense with submitting the question to the registered voters, and in lieu thereof to declare the territory annexed by Ordinance, following the public hearing on the question,

NOW, THEREFORE, BE IT ORDAINED BY THE PEOPLE OF THE CITY OF LEBANON:

Section 1: A public hearing shall be had at 8:00 o'clock
P. M., on the 15th day of August, 1967, in the Council Chambers
at the City Hall in the City of Lebanon, County of Linn, State of
Oregon, before the Common Council of said City of Lebanon, at
which time and place the registered voters of the City of Lebanon
may appear and be heard on the question of the annexation of the
following described area, to-wit:

Beginning at the intersection of the West boundary of the present City limits and the Southerly boundary of the Southern Pacific Railroad right of way said point also being 30 ft. east and approximately 510 ft. north from the northeast corner of Block 5 of Mountain View Addition to Lebanon; thence northwesterly along the southerly boundary of said railroad right of way 1540 ft. more or less to the northwest corner of that tract of land described on page 167 of Volume 184, Linn County geed records; thence south along the west line of said property 387.67 ft. thence \$65°42'E 732.06 ft. to the west line of Hansard avenue; thence north 85 ft; thence east 60 feet more or less to a 5/8" iron rod which is north Q°44' west 540 feet from the northwest corner of Block 4 in Mountain View addition to the City of Lebanon; thence north 89°17' east 216,125 ft. to a 5/8" iron rod; thence South 0° 43' east 330.13 ft. to a 3/4" iron pipe; thence north 89°191 east 115 ft. to a 3/4" iron pipe; thence south 0°431 east 150 ft. to a 3/4" iron pipe on the north line of Harrison street; thence north 89°191 east 45 ft. to a 3/4" iron pipe; thence north 0°441 west 150 ft. to a ½" pipe; thence north 89°19¹ east 46 ft. to a ½" pipe; thence north 103.1 ft. to the southwest corner of the Union Oil Company property that is described on page 486 of Volume 128 of Linn County deed records; thence East along the South Line of the Union Oil property 227 ft. to an interior corner; thence south along the westline of 7th street 253.1 ft. to the north line of Harrison street; thence east 30 ft. to the present City limits of Lebanon; thence North along present City boundary to the place of beginning.

and whether or not the Common Council shall dispense with submitting the question to the registered voters of the City of Lebanon.

Section 2. The Recorder of the City of Lebanon is hereby directed to publish a notice of this hearing, once weekly for two successive weeks prior to the day above set for the hearing, in a newspaper of general circulation in the City of Lebanon, and the Recorder shall post notices of the hearing in four public places in the City for a like period of time.

Section 3. Conditions are such that said annexation, if allowed, should be made within the near future, and, it being necessary for the peace, health and general welfare of the residents of the City of Lebanon that said hearing be held as soon as possible, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
