ORDINANCE NO. 1301

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. Ordinance No. 2, enacted August 4, 1891, relating to nuisances, is repealed.

Section 2. Ordinance No. 84, enacted October 28, 1908, relating to cesspools and privies, is repealed.

Section 3. Ordinance No. 180, enacted January 5, 1915, relating to house numbering, is repealed.

Section 4. Ordinance No. 191, enacted April 20, 1915, relating to weed and rubbish control, is repealed.

Section 5. Ordinance No. 468, enacted August 20, 1935, relating to following fire apparatus, is repealed.

Section 6. Ordinance No 519, enacted December 3, 1940, relating to offenses, is repealed.

Section 7. Ordinance No 551, enacted July 15, 1941, relating to removal of rubbish, is repealed.

Section 8. Ordinance No. 572, enacted November 27, 1942, relating to animals at large, is repealed.

Section 9. Ordinance No. 604, enacted December 6, 1943, relating to intoxicating liquor, is repealed.

Section 10. Ordinance No. 644, enacted June 17, 1947, relating to street and sidewalk excavations, is repealed.

Section 11. Ordinance No. 650, enacted October 21, 1947, relating to street and sidewalk excavations, is repealed.

Section 12. Ordinance No. 739, enacted September 20, 1949, relating to vagrancy, is repealed.

Section 13. Ordinance No 896, enacted February 15, 1955, relating to civil defense, is repealed.

Section 14. Ordinance No 1065, enacted November 10, 1959, relating to vagrancy, is repealed.

Section 15. Ordinance No 1114, enacted January 15, 1963, relating to stolen property is repealed.

Section 16. Ordinance No 1117, enacted March 5, 1963, relating to false reports to police, is repealed.

Section 17. Ordinance No. 1125, enacted June 18, 1963, relating to removal of rubbish, is repealed.

Section 18. Ordinance No 1137, enacted October 22, 1963, relating to parking of vehicles on private property, is repealed.

Section 19. Ordinance No 1140, enacted February 4, 1964, relating to larceny, is repealed.

Section 20. Ordinance No. 1152, enacted July 21, 1964, relating to false reports to police, is repealed.




Section 21. Ordinance No 1162, enacted October 6, 1964, relating to weed and rubbish control, is repealed.

Section 22. Ordinance No. 1176, enacted March 2, 1965, relating to false reports to police, is repealed.

Section 23. Ordinance No 1237, enacted February 7, 1967, relating to escape from custody, is repealed.

Section 24. Emergency Clause; that existing conditions are such that this Ordinance is necessary for the immediate preservation of the public peace, health, and safety, and an emergency is hereby declared and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
