ORDINANCE BILL NO. 32
for 1968
ORDINANCE NO. 1324

WHEREAS, the owners of all of the property abutting upon the street improvement district for the construction of a sidewalk on the west side of Fourth Street between A Street and B Street in the City of Lebanon have filed their petition asking for the City to make said street improvement and charge the same to said petitioners; and

WHEREAS, said sidewalk was built under the supervision of the Street Superintendent, who kept an accurate record of the cost of building such sidewalk in front of each lot and parcel of land, pursuant to the direction of Resolution No. 16 for 1967, and has reported the same to the owners and to the Council; and

WHEREAS, said work has been accepted and approved by the aforesaid petitioners,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That the cost of said sidewalk construction is \$858.24.

Section 2. That the proportionate share of said cost of said work and improvement to be borne by the real property especially benefitted thereby, and to be assessed therefor, is hereby declared to be the amount set immediately after the separate description of each lot or tract of land hereinafter stated, and each of said lots or tracts of land is determined and declared to be benefitted by said improvements in the sum equal to or greater than the amount assessed thereto hereinafter; and each of said lots or tracts of land should be, and the same hereby is, assessed for its proportionate share of the cost of said improvements in the sum set opposite the description, to-wit:

Section 3. That the Recorder of the City of Lebanon be, and he is hereby, ordered and directed to immediately enter a statement of each assessment made, declared and levied by this Ordinance, together with the names of the respective owners of such lots and tracts of land hereinabove described, in the Docket of City Liens of said City, as provided by the Charter; and to give notice forthwith to the owners of all of said property as to said assessments as provided by the Charter of said City of Lebanon.

Section 4. That the said City of Lebanon, having seriously depleted its funds and this Ordinance, therefore, being required for the peace, health and safety of said City, an emergency is hereby declared and said Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
