

A BILL FOR AN ORDINANCE ANNEXING CERTAIN
PROPERTY FOLLOWING HEARING AND UPON THE
WRITTEN CONSENT FILED WITH THE CITY
COUNCIL BY LANDOWNERS IN SAID AREA,
PURSUANT TO ORS 222.120 AND ORS 222.170,
AND DECLARING AN EMERGENCY.

ORDINANCE BILL NO. 10
for 1970

ORDINANCE NO. 1369

WHEREAS, a public hearing was held as provided in Ordinance No. 1366, pursuant to the provisions of ORS 222.120; and

WHEREAS, as provided in ORS 222.170, at least two-thirds of the landowners of the property described below, who also own at least two-thirds of the land in said territory, which represents at least two-thirds of the assessed value of all real property in said territory, have, prior to the public hearing, consented in writing to the annexation and have filed a statement of their consent with the City Council; and

WHEREAS, said real property is contiguous territory to the City of Lebanon;

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. The following described property is hereby annexed to the City of Lebanon, Oregon, to-wit:

Lots 1, 2, 3 Lord's Addition; Tax Lot #801 as shown on Linn County Assessor's Map #12-2W-15DB; the West 60 feet of Lot 17; the North 39 feet of Lot 18; Lots 19, Block 1, Ingrid Subdivision; and Lots 1 and 2, Block 6, Ingrid Subdivision.

Section 2. The City Recorder is hereby directed to make and submit to the Secretary of the State of Oregon a copy of this Ordinance, together with a copy of the statement of consent of the landowners in said territory, and also a copy of Ordinance No. 1366 declaring that no election shall be required within the City of Lebanon.

Section 3. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
