ORDINANCE NO. 1383

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. Section 7 of Ordinance No. 641 is amended by deleting the words "one-cent" on line 4 of said Section and inserting in lieu thereof "ten-cent".

Section 2. New sections numbered 16 (a), (b), and (c) are added and shall read as follows:

"16 (a) Notwithstanding any other provision herein, the courtesy parking system adopted by the City Council is hereby enacted."

"16 (b) The courtesy parking envelope attached hereto and set forth below, is adopted as the official envelope form to be used in the courtesy parking program, and the statements and recitations printed thereon shall be part of the ordinances of the City."

"16 (c) Each courtesy ticket in excess of two, which is received by any one person and/or operator in a calendar month, shall constitute an over-time parking violation punishable pursuant to the provisions of Section 13 and other sections of this Ordinance, and for which a complaint may be filed against said person and/or operator.


Section 3. Section 8 of Ordinance No. 641 is amended to read as follows:

"Section 8. It shall be unlawful and a violation of the provisions of this ordinance for any person to cause, allow permit, or suffer any vehicle registered in the name of, or operated by such person to:

- (1) Be parked over-time or beyond the period of legal parking time established for any parking meter zone as herein described.
- (2) Be parked more than two successive hours in any one metered space.

Section 4. That inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
