OF TRUE CASH VALUE OF ALL THE TAXABLE PROPERTY WITHIN THE CITY LIMITS, BASED ON THE 1971-72 ASSESSED VALUATION; (2) A PROPOSITION AUTHORIZING A LEVY BY THE CITY OF A TAX IN THE SUM OF \$16,000. OUTSIDE THE CONSTITUTIONAL) LIMITATIONS, FOR THE PURPOSE OF PROVIDING FUNDS FOR THE CONTINUANCE OF AMBULANCE SERVICE) WITHIN THE CITY OF LEBANON AND FOR THE PURCHASE OF AN AMBULANCE, THE ESTIMATED RATE OF TAX NECESSARY THEREFOR BEING \$0.358 PER \$1,000. OF TRUE CASH VALUE OF ALL THE TAXABLE PROPERTY WITHIN THE CITY LIMITS, BASED ON THE 1971-72 ASSESSED VALUATION; (3) A PROPOSITION AUTHORIZING A LEVY BY THE CITY OF A TAX IN THE SUM OF \$9,310. OUTSIDE THE CONSTITUTIONAL) LIMITATIONS FOR THE PURPOSE OF PROVIDING FUNDS) FOR THE OPERATION OF A DOG CONTROL DEPARTMENT WITHIN THE CITY OF LEBANON, THE ESTIMATED RATE OF TAX NECESSARY THEREFOR BEING \$0.208 PER \$1,000. OF TRUE CASH VALUE OF ALL THE TAXABLE PROPERTY WITHIN THE CITY LIMITS, BASED ON THE 1971-72 ASSESSED VALUATION; and (4) A PROPOSITION CENTRE A CITY-MANAGER FORM OF GOVERNMENT, AND REPEALING ALL THE PROVISIONS OF THE PRESENT CITY CHARTER, TO TAKE EFFECT JANUARY 1, 1973; AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS: <u>Section 1.</u> That a special election be held in the City of Lebanon, Linn County, Oregon, on the 24th day of April, 1972, for the purpose of submitting proposed tax levies in excess of the 6% constitutional limitation which is now on file in the office of the Recorder of the City of Lebanon, which has been proposed by the Council by Resolution No. <u>5</u> heretofore passed; and for the purpose of submitting the proposition relating to the City-Manager form of government which is now on file in the office of the Recorder of the City of Lebanon, which has been proposed by the Council by Resolution No. 2 heretofore passed, and more specifically set forth as follows:

SHALL the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$253,767. at the estimated rate of \$5.68 per \$1,000. of true cash value against all the taxable property within the City Limits, and outside the constitutional 6% limitation of the State of Oregon, for the fiscal tax year 1972-73, for the purpose of providing funds for the operation and maintenance of departments of the General Fund?

PROPOSITION (2)

Shall the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$16,000. at the estimated rate of \$0.358 per \$1,000. of true cash value against all the taxable property within the City Limits, and outside the constitutional 6% limitation of the State of Oregon, for the fiscal tax year 1972-73, for the purpose of providing funds for the continuance of ambulance service within the City of Lebanon and for the purchase of an ambulance?

PROPOSITION (3)

Shall the City of Lebanon, Linn County, Oregon, by and through its Common Council, be authorized to levy a tax in the sum of \$9,310. at the estimated rate of \$0.208 per \$1,000. of true cash value against all the taxable property within the City Limits, and outside the c constitutional 6% limitation of the State of Oregon, for the fiscal tax year 1972-73, for the operation of a Dog Control department within the City of Lebanon?

PROPOSITION (4)

Shall the proposed new City Charter **Stablishing** a Council-Manager form of government be adopted and all of the provisions of the present City Charter be repealed, to take effect January 1, 1973?

<u>Section 2.</u> That the Recorder of the City of Lebanon is hereby authorized to publish and post notices of said election in the manner provided by law; and further he shall place said proposal on the official ballot to be voted on by the legal electors at said election.

<u>Section 5.</u> That the polling places for said election shall be open from the hours of 8:00 o'clock A. M. to 8:00o'clock P. M., on said day and that the Chief of Police is instructed to take to the polling places booths, pens, pencils and ballots for the purpose of providing for said election and the Recorder is directed to provide poll books therefor.

Section 6. Inasmuch as the City of Lebanon will be without funds to maintain its services in the coming fiscal year unless the special election herein referred to can be held without delay, the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this ^Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
