

A BILL FOR AN ORDINANCE FIXING A DAY) ORDINANCE BILL NO. 16
FOR PUBLIC HEARING UPON THE QUESTION) for 1972
OF DISPENSING WITH AN ELECTION WITHIN)
THE CITY FOR ANNEXATION OF CERTAIN) ORDINANCE NO. 1442
TERRITORY, AND DECLARING AN EMERGENCY.)

WHEREAS there has been filed with the City of Lebanon written petitions for the annexation of the area described below; and

WHEREAS the City Charter of the City of Lebanon does not expressly prohibit the City from dispensing with submitting the question of annexation to the registered voters of the City; and

WHEREAS, pursuant to the provisions of ORS 222.120, the City Council has elected to dispense with submitting the question to the registered voters, and in lieu thereof to declare the territory annexed by Ordinance following the public hearing on the question,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. A public hearing shall be held at 8:00 o'clock P. M. on the 5th day of September, 1972, in the Council Chambers of the City Hall in the City of Lebanon, County of Linn, State of Oregon, before the Common Council of said City, at which time and place the registered voters of the City of Lebanon may appear and be heard on the question of the annexation of the following described area, to-wit:

Beginning at the Northeast Corner of Lot 5, Block 1, ROBERTSON ADDITION, thence East along the South line of Ede's Addition 500 feet; thence South $0^{\circ} 34'$ West 51.64 feet; thence S. $22^{\circ} 30'$ West 130.25 feet; thence along a 131.08 foot radius curve Southeasterly 51.47 feet through $22^{\circ} 30'$ of arc (the chord bears S. $56^{\circ} 15'$ E. 51.14 feet); thence S. 45° E. 57.20 feet; thence S. 45° West 46.87 feet; thence West 500.75 feet to the Southeast Corner of Robertson Addition; thence N. $0^{\circ} 16'$ East 274 feet to the place of beginning.

ALSO: The South 61 feet of the West 70 feet of Lot 26 and the North 39 feet of the West 70 feet of Lot 32, except that portion already lying within the City Limits, and being a portion of Lots 26 and 32, HYLAND ADDITION, Lebanon, Linn County, Oregon.

and whether or not the Common Council shall dispense with submitting the question to the registered voters of the City of Lebanon.

Section 2. The Recorder of the City of Lebanon is hereby directed to publish a notice of this hearing once weekly for two successive weeks prior to the day above set for the hearing, in a newspaper of general circulation in the City of Lebanon, and the Recorder shall post notices of the hearing in four public places in the City for a like period of time.


Section 3. Conditions are such that said annexation, if allowed, should be made within the near future, and, it being necessary for the peace, health and general welfare of the residents of the City of Lebanon that said hearing be held as soon as possible, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
