ORDINANCE NO.

WHEREAS, a public hearing was held as provided in Ordinance No. 1468, pursuant to the provisions of ORS 22.120; and

WHEREAS, as provided in ORS 222.170, at least two-thirds of the landowners of the property described below, who also own at least two-thirds of the land in said territory, which represents at least two-thirds of the assessed value of all real property in said territory, have, prior to the public hearing, consented in writing to the annexation and have filed a statement of their consent with the City Council; and

WHEREAS, said real property is contiguous territory to the City of Lebanon;

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. The following described property is hereby annexed to the City of Lebanon, Oregon, to-wit:

(10 ft. wide strip of land of even width from City Sewage Treatment Plant to City Sanitary Land Fill Site).

A strip of land 10 ft. wide of even width, in Sections 1 and 2, Township 12 South, Range 2 West, W.M., Linn County, Oregon, described as follows:

The point of beginning, which is also the most westerly southwest corner of said 10 ft. wide strip, is South 10.0 ft. and East 40 ft. from the NE corner of a 5.51 acre tract deeded to the City of Lebanon per LinnCounty Deed Vol. 231, page 670, said point of beginning being on the Easterly right-of-way line of a 40 ft. wide Linn County Road #702 and being 20.0 ft. 
