

A BILL FOR AN ORDINANCE PROVIDING FOR :  
NOTICE OF PROPOSED ASSESSMENTS ON  
PROPERTY ESPECIALLY BENEFITTED THEREBY  
FOR THE COST OF STREET IMPROVEMENTS OF  
EDDIE STREET FROM ELMORE STREET SOUTH TO  
END; DOWNING DRIVE; RANDALL STREET; DAVID  
DRIVE; POST STREET FROM MILTON STREET  
SOUTH TO THE SOUTH LINE OF DOWNING ADDITION;  
HARRISON STREET FROM SEVENTH STREET EAST TO  
SIXTH STREET; AND THIRD STREET FROM VINE  
STREET TO MAPLE STREET; AND "E" STREET FROM  
SEVENTH STREET TO TENTH STREET; and  
SANITARY SEWER IMPROVEMENTS TO SERVE DOWNING  
ADDITION, and DECLARING AN EMERGENCY.

ORDINANCE NO. 1634

WHEREAS the work and improvements referred to in the title of this Ordinance have been completed and approved in accordance with the Charter and Ordinances of the City of Lebanon, and the cost of said work and improvements has been determined, and the proposed assessments to the respective lots within the districts are on file with the Lebanon City Recorder; and notice should be given to the owner of each lot,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. Notice of said proposed assessments for the following improvements shall be mailed or personally delivered to the owner of each Lot proposed to be assessed, which notice shall state the amount of assessment proposed on that property, and that objections stating the grounds therefor shall be filed with the City Recorder on or before Wednesday, May 25, 1977.

STREET IMPROVEMENTS of Eddie Street from Elmore Street south to end; Downing Drive; Randall Street; David Drive; Post Street from Milton Street South to the South line of Downing Addition; Harrison Street from Seventh Street east to Sixth Street; Third Street from Vine Street to Maple Street; and "E" Street from Seventh Street to Tenth Street;

SANITARY SEWER IMPROVEMENTS to Downing Addition

Section 2. That the said City of Lebanon having seriously depleted its funds and this Ordinance, therefore, being required for the peace, health and safety of said City, an emergency is hereby declared and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.

Passed by the Council by a vote of 6 for and 0 against, and approved by the Mayor this 13 day of April, 1977.
