WHEREAS, a public hearing was held as provided in Ordinance No. 1656, pursuant to the provisions of ORS 222.120; and

WHEREAS, as provided in ORS 222.170, more than half of the landowners of the property described below, who also own more than half of the land in said territory, which represents more than half of the assessed value of all real property in said territory, have, prior to the public hearing, consented in writing to the annexation and have filed a statement of their consent with the City Council; and

WHEREAS, said real property is contiguous territory to the City of Lebanon,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. The following described property is hereby annexed to the City of Lebanon, Oregon, to-vit:

PARCEL I:

Beginning at a 3/4" iron pipe which bears West along the South line and 5.45 feet distant from the Southeast corner of Lot 6, Block 2, South Cedar Subdivision in Township 12 South, Range 2 West of the Willamette Meridian; thence West along the South line of said Subdivision 282 feet (282.98 by records) to an iron pipe at the Northeast corner of that property conveyed to Eugene C. Durlam et ux, by deed recorded in Deed Book 269, page 86, thence South 0°31½' West along the East line of said Durlam tract 310.5 feet to an 5/8" iron rod; thence East parallel with the South line of South Cedar Subdivision, 279.50 feet to a 5/8" iron rod on the East line of grantors property; thence North 0°59½' East on the East line of said property 310.5 feet to the point of beginning, all in Linn County, Oregon.

All of the above described property being situated in Linn County, Oregon. Section 2. The City Recorder is hereby directed to make and submit a copy of this Ordinance, together with a copy of the statement of consent of the landowners in said territory, and also a copy of Ordinance No. 1656 declaring that no election shall be required within the City of Lebanon, to the appropriate State and County officials.

Section 3. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
