ORDINANCE NO. 1702

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That the following streets and alleys, to-wit:

Ash Street from 10th Street to 11th Street, legally

described as:

Beginning at the Northeast corner of the Ash Street and 11th Street right-of-way intersection; thence Easterly along the North right-of-way line of Ash Street to the Northwest corner of Ash Street and 10th Street right-of-way intersection; thence Southerly along the 10th Street right-of-way line to the Southwest corner of 10th and Ash Street right-of-way intersection; thence Westerly along the Southerly right-of-way line of Ash Street to the Southeast corner of Ash Street and 11th Street right-of-way intersection; thence Northerly to the point of beginning. All being within the City limits of Lebanon, Oregon.

SAVE AND EXCEPT a 30 foot utility easement of even width measured from and parallel to the Northerly right-of-way line of Ash Street.

All Streets and Alleys within the Alvin Subdivision,

except Division Way, legally described as:

All of the streets and alleys within the following described portion of the Alvin's Subdivision as recorded in book 9, page 46, records of Linn County, Oregon, and revised by survey number C.S. 7678 as recorded in the Linn County Surveyor's office, to-wit: beginning at the northerly most corner of Lot 9, Block 1, of said Alvin's Subdivision; thence S.  $47^{\circ} 42'$  E., 420.00 ft. to the northeast corner of Lot 3, Block 1; thence S.  $42^{\circ} 18'$  W. 252 ft. to the southerly corner of Lot 17, Block 1; thence S.  $51^{\circ} 55'$  W., 50.71 ft. to the southeast corner of Lot 1, Block 2; thence S.  $71^{\circ} 47'$  W., 121.42 ft. to the southwest corner of Lot 2, Block 2; thence N.  $47^{\circ} 42'$  W. 331.77 ft. to the northwest corner of Lot 7, Block 2; thence N.  $42^{\circ} 18'$  E., 407.7 ft. to the point of beginning in Lebanon, Linn County, Oregon.

be and the same are hereby vacated.

Section 2. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
