A BILL FOR AN ORDINANCE FIXING A DAY FOR PUBLIC HEARING UPON THE QUESTION OF DISPENSING WITH AN ELECTION WITHIN THE CITY FOR ANNEXATION OF CERTAIN TERRITORY, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 1703

WHEREAS the Common Council of the City of Lebanon desires to annex two areas as described below, presently surrounded by the City limits; and

WHEREAS the City Charter of the City of Lebanon does not expressly prohibit the City from dispensing with submitting the question of annexation to the registered voters of the City; and

WHEREAS, pursuant to the provisions of ORS 222.120, the City
Council has elected to dispense with submitting the question to the
registered voters, and in lieu thereof to declare the territory annexed
by Ordinance following the public hearing on the question,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. A public hearing shall be held at 8:00 P.M. on the 23rd day of August, 1978, in the Council Chambers of the City Hall in the City of Lebanon, County of Linn, State of Oregon, before the Common Council of said City, at which time and place the registered voters of the City of Lebanon may appear and be heard on the question of the annexation of the following described area, to-wit:

Lots 3,4,5 and 6, Supplemental Plat of Blocks 16 to 19 inclusive, in A.F. Bahrke's Fruitdale Addition to Lebanon, Linn County, Oregon, AND ALSO, Beginning at the northeast corner of Lot 3, Supplemental Plat of Blocks 16 to 19 inclusive, in A.F. Bahrke's Fruitdale Addition to Lebanon, Linn County, Oregon, said point also lying on the south line of Sherman Street; thence westerly along said south line 393 feet, more or less, to the east line of Tenth Street; thence northerly 60 feet, more or less, along said east line to the north line of Sherman Street; thence easterly 393 feet, more or less, along said north line; thence southerly 60 feet, more or less, to the point of beginning, AND ALSO, Beginning at the northeast corner of Lot 1, Supplemental Plat of Blocks

Beginning at the northeast corner of Lot 1, Supplemental Plat of Blocks 16 to 19 inclusive of A.F. Bahrke's Fruitdale Addition to Lebanon, Linn County, Oregon; thence northerly 60 feet, more or less, to the north line of Sherman Street; thence east along said north line 248.86 feet, more or less, to the east line of Eighth Street; thence southerly along said east line 192.75 feet, more or less; thence westerly and parallel to the north line of Sherman Street 248.86 feet, more or less, to the southeast corner of the before mentioned Lot 1; thence northerly along the east line of said Lot 1 132.99 feet, more or less, to the point of beginning.

and whether or not the Common Council shall dispense with submitting the question to the registered voters of the City of Lebanon.

Section 2. The Recorder of the City of Lebanon is hereby directed to publish a notice of this hearing once weekly for two successive weeks prior to the day above set for the hearing, in a newspaper of general circulation in the City of Lebanon, and the Recorder shall post notices of the hearing in four public places in the City for a like period of time.

Section 3. Conditions are such that said annexation, if allowed, should be made within the near future, and, it being necessary for the peace, health and general welfare of the residents of the City of Lebanon that said hearing be held as soon as possible, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
