WHEREAS, a public hearing was held as provided in Ordinance No. 1714, pursuant to the provisions of ORS 222.120; and

WHEREAS, as provided in ORS 222.170, more than half of the landowners of the property described below, who also own more than half
of the land in said territory, which represents more than half of the
assessed value of all real property in said territory, have, prior to
the public hearing, consented in writing to the annexation and have
filed a statement of their consent with the City Council; and

WHEREAS, said real property is contiguous territory to the CITY OF LEBANON,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. The following described property is hereby annexed to the City of Lebanon, Oregon to-wit:
