WHEREAS, a public hearing was held as provided in Ordinance No. 1687, 1690, 1693, 1703, 1704,1714, pursuant to the provisions of ORS 222.520; and

WHEREAS, the property described below in the Lebanon
Rural Fire Protection District and the Grand Prairie Water
Control District has been annexed to the City of Lebanon; and

WHEREAS, as provided in ORS 222.524, the Common Council has determined that the withdrawal of said property from said Districts is for the best interest of the City of Lebanon, now therefore,

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. The following described property is hereby withdrawn from the Lebanon Rural Fire Protection District and the Grand Prairie Water Control District:

ANNEXATION 77-3

PARCEL #1:

Section 2. The City Recorder is hereby directed to make and submit a copy of this Ordinance and a copy of Ordinance No. 1687, 1690, 1693, 1703,1704,1714calling for the public hearing, to the appropriate state and county officials.

Section 3. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
