

A BILL FOR AN ORDINANCE ANNEXING CERTAIN) ORDINANCE BILL NO. 3
PROPERTY FOLLOWING HEARING PURSUANT TO) for 1979
ORS 222.120, AND DECLARING AN EMERGENCY.) ORDINANCE NO. 1726

WHEREAS, a public hearing was held as provided in Ordinance No. 1725, pursuant to the provisions of ORS 222.120; and

WHEREAS, the Common Council of the City of Lebanon desires to annex the area described below; and

WHEREAS, said real property is presently surrounded by the City Limits; now therefore

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. The following described property is hereby annexed to the City of Lebanon, Oregon, to-wit:

Beginning South 31.37 chains and West 66.65 chains from the N.E. corner of the Russell T. Hill D.L.C. No. 77, T. 12 S. R. 2 W, Willamette Meridian, Linn County, Oregon; thence easterly 317.5 feet to the true point of beginning; thence northerly 438 feet, plus or minus, to the N.W. corner of Tax Lot 500, Tax Map 12-2W-15DA, Linn County, Oregon; thence easterly, 310.5 feet, plus or minus, to the centerline of U. S. Highway 20 (South Santiam); thence southerly, along said centerline, 438 feet, plus or minus; thence westerly, 310.5 feet, plus or minus, to the true point of beginning.


and is zoned as C-H, Highway Commercial.

City of Lebanon, to the appropriate state and county officials.




