ORDINANCE NO. 1763

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That the following street to-wit:

Beginning at the Northeast corner of Lot 11 Block 1, "Mountain Shadows" Mobile Home Estates, a subdivision of record in the City of Lebanon, Linn County, Oregon; thence South 89°54'03" East 50.00 feet; thence South 00°35' West 0.42 feet; thence along the arc of a 55.00 foot radius curve left (the long chord of which bears South 26°10'25" East 49.52 feet) 51.37 feet; thence along the arc of a 105.00 foot radius curve right (the long chord of which bears South 26°13'02" East 94.40 feet) 97.91 feet; thence North 89°30'14" West 50.00 feet; thence North 00°29'46" East 29.10 feet; thence North 89°54'03" West 63.46 feet; thence along the arc of a 13.00 foot radius curve left (the long chord of which bears North 44°49'38" East 18.10 feet) 20.02 feet; thence North 00°35' East 18.52 feet; thence along the arc of a 70.00 foot radius curve left (the long chord of which bears North 10°55'59" West 27.95 feet) 28.14 feet; thence along the arc of a 105.00 foot radius curve right (the long chord of which bears North 10°55'59" West 41.93 feet) 42.21 feet to the point of beginning. Excepting Tract "E" of said Mountain Shadows, including the utility easements which are five (5) feet in width along the street frontages described above; also the 15.00 foot wide easement the centerline of which is the South line of Lots 2 and 7 Block 5 said Mountain Shadows.

be and the same is hereby vacated.

Section 2. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.

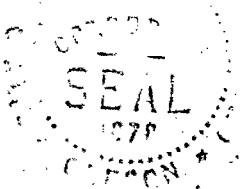
