

AN ORDINANCE CALLING A SPECIAL ELECTION ON JUNE 24, 1980, SUBMITTING TO THE LEGAL ELECTORS OF THE CITY OF LEBANON TWO PROPOSITIONS DESIGNATED AS BALLOT "A" AND BALLOT "B" AUTHORIZING A LEVY BY THE CITY OF A TAX IN THE SUM OF \$585,885 ON THE "A" BALLOT AND \$85,513 ON THE "B" BALLOT OUTSIDE THE CONSTITUTIONAL LIMITATION FOR THE PURPOSE OF PROVIDING FUNDS FOR THE OPERATION AND MAINTENANCE OF ALL DEPARTMENTS OF THE GENERAL FUND, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 1785

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That a special election be held in the City of Lebanon, Linn County, Oregon on the 24th day of June, 1980, for the purpose of submitting proposed tax levies in excess of the 6% Constitutional Limitation which are now on file in the office of the Recorder of the City of Lebanon, which has been proposed by the Council, and more specifically set forth as follows:

"A" BALLOT - TAX LEVY OUTSIDE THE CONSTITUTIONAL LIMITATION

Shall the City of Lebanon be authorized to levy a tax on property in the sum of \$585,885?

Purpose: The amount requested is to provide funds for the operation and maintenance of departments of the General Fund for the fiscal year 1980-81.

Explanation: If this measure is approved, \$585,885 of the taxes levied will be financed partially by the State of Oregon and designated as the "A" ballot. The remainder of the requested levy, \$85,513 is submitted as a separate measure and is designated as the "B" ballot.

The combined total of the "A" and "B" ballots equal the \$671,398 required to balance the budget. The "B" portion of the ballot cannot be imposed unless the "A" portion of the ballot also passes.

"B" BALLOT - TAX LEVY OUTSIDE THE CONSTITUTIONAL LIMITATION

Shall the City of Lebanon be authorized to levy a tax on property in the sum of \$85,513?

Purpose: The amount requested is to provide funds for the operation and maintenance of departments of the General Fund for the fiscal year 1980-81.

Explanation: If this measure is approved, \$85,513 of the taxes levied will be totally financed by local taxpayers without any partial State payment. The combined total of the "A" and "B" ballots represent the revenue required to balance the operational budget of the City for the next year. The "B" portion of the ballot cannot be imposed unless the "A" portion of the ballot also passes.


Section 2. That the Recorder of the City of Lebanon is hereby authorized to publish notice of said election in a newspaper of general circulation within the City at least ten (10) days prior to election, and further he shall place said proposal in the official ballot to be voted on by the legal electors of said election.

Section 3. That the polling places for said election in the City of Lebanon shall be those designated by the Linn County Clerk for special elections; the poll books adopted for Lebanon by the Linn County Clerk as the poll books for said election are hereby adopted as the poll books for the special election; the Judges and Clerks of election appointed by the Linn County Clerk to serve in Lebanon at said special election are hereby designated as the Judges and Clerks of and for the City special election.

Section 4. The polls for the City special election shall be open from the hours of 8:00 a.m. to 8:00 p.m. on said day.


Section 5. That inasmuch as the City of Lebanon will be without funds to maintain its services in the coming fiscal year unless the special election herein referred to can be held without delay, the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
