THE CITY OF LEBANON ORDAINS AS FOLLOWS:

Structural Code. The State of Oregon Structural Section 1. Specialty Code and Fire Life Safety Code is adopted as the structural code of the City. The foregoing is composed of the 1979 edition of the Uniform Building Code with its appendices and separately bound standards, published by the International Conference of Building Officials and modified by the director of the Oregon Department of Commerce and the State Fire Marshal.

Mechanical Code. The State of Oregon Mechanical Section 2. Specialty Code and Mechanical Fire Life Safety Code is adopted as the mechanical code for the City. The foregoing is composed of the 1979 edition of the Uniform Mechanical Code with its appendices, published by the International Conference of Building Officials and modified by the director of the Oregon Department of Commerce and the State Fire Marshal.

Section 3. Plumbing Code. The State of Oregon Plumbing Specialty Code is adopted as the plumbing code for the City. The foregoing is composed of the 1976 edition of the Uniform Plumbing Code, Chapters 1 through 13 and appendices, published by the International Association of Plumbing and Mechanical Officials and amended by State of Oregon Supplements.

<u>Section 4</u>. <u>Housing Code</u>. The Uniform Housing Code, 1979 edition, published by the International Conference of Building Officials is adopted as the housing code for the City.

Section 5. Abatement of Dangerous Buildings Code. The Uniform Code for the Abatement of Dangerous Buildings, 1979 edition, published by the International Conference of Building Officials is adopted as the abatement of dangerous buildings code for the City.

Section 6. Agricultural Buildings. Appendix Chapter 11, Agricultural Buildings, of the 1979 edition of the Uniform Building Code, published by the International Conference of Building Officials is adopted as part of the structural code, as adopted under Section 1 of this ordinance.

Section 7. Effect of Failure to Inspect. Notwithstanding any provision of the Housing Code or Abatement of Dangerous Buildings Code requiring inspections, the City and its officers, agents and employees, while retaining the right to do so, shall not be obligated to conduct any of the inspections referred to

or provided for in said codes. The City, or any department, official, agent or employee, shall not be liable in damages or otherwise for any failure to inspect, or for any damages alleged to be or in fact caused by a non-inspection or failure to inspect anything or premises as provided in the Housing Code or Abatement of Dangerous Buildings Code.

Section 8. Severability. If any section, paragraph, sentence or word of this ordinance or codes adopted herein be declared for any reason to be invalid, such invalidity shall not effect the remainder of this ordinance or any of the codes adopted herein and, to that end, the provisions thereof are declared to be severable.

Section 9. Repealing Clause. Ordinances No. 1355, 1532, 1591, 1671, and 1721, and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.

Emergency Clause. That, inasmuch as the pro-Section 10. visions of this ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect immediately upon its passage by the City Council and approval by the Mayor.
