ORDINANCE NO. 1887

THE CITY OF LEBANON ORDAINS AS FOLLOWS:

Section 1. That a special election be held in the City of Lebanon, Linn County Oregon on the 29th day of June, 1982, for the purpose of submitting a proposed tax levy in excess of the tax base.

Section 2. At the special election the following measure shall be submitted to the legal electors of the City of Lebanon for their approval or rejection:

ONE YEAR SPECIAL LEVY

Question: Shall the City of Lebanon levy \$155,000 outside the tax base towards operation of Police and Fire Departments for 1982-83?

Statement: Due to decreases in anticipated revenue during the 1981-82 fiscal year, substantial spending cuts were made during the 1981-82 fiscal year. These cuts included the Police and Fire Departments. If this measure is approved, budgeted spending for the Police and Fire Departments will be restored to the approximate levels which were originally budgeted for the 1981-82 fiscal year. If this measure is approved, \$155,000 of the taxes levied in the 1982-83 fiscal year will be financed partially by the State of Oregon.

Section 3. The Recorder of the City of Lebanon is hereby authorized to publish notice of said election in a newspaper of general circulation within the City at least ten (10) days prior to said election; and further he shall place


the said measure on the official ballot to be voted on by the legal electors of said election.

Section 4. The polling places for said election in the City of Lebanon shall be those designated by the Linn County Clerk for special elections; the poll books adopted for Lebanon by the Linn County Clerk as the poll books for said election are hereby adopted as the poll books for the special election; the Judges and Clerks of election appointed by the Linn County Clerk to serve in Lebanon at said special election are hereby designated as the Judges and Clerks of and for the City special election.

Section 5. The polls for the City special election shall be open from the hours of 8:00 a.m. to 8:00 p.m. on said day.


Section 6. That inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
