## THE CITY OF LEBANON ORDAINS AS FOLLOWS:

Section 1. Section 9.040.020 of the Lebanon Municipal Code is hereby amended to incorporate by reference ORS 357.975 and 357.990, as amended by the 1983 Oregon Legislature.

<u>Section 2.</u> Section 9.04.030 of the Lebanon Municipal Code is hereby amended to read as follows:

"9.04.030. State Provisions Applicable to Adopted Statues.

There are also incorporated by reference any definitions, sections or provisions of Oregon Revised Statutes, including amendments, changes or substitutions enacted by the 1983 Oregon Legislature, which reasonably apply to the Statutes incorporated in Section 9.040.020."

Section 3. Section 10.04.020 of the Lebanon Municipal Code is hereby amended to read as follows:

"10.04.020.. State Provisions Adopted - Prosecution Authority. The following Chapters and Provisions of Oregon Revised Statutes are incorporated by reference into the Ordinance codified at this title as though fully set forth in this Section and any violation or failure to comply with such Chapters or provisions shall be a violation of this title: Chapter 481, Chapter 482, Chapter 483, Chapter 484, Chapter 485, Chapter 486, and Chapter 487. Additionally, there are incorporated by reference any other Sections or provisions of Oregon Revised Statutes relating to punishment for violations of the Motor Vehicles Laws incorporated in this Section. The City Attorney shall have the authority to prosecute violations of this title on behalf of the City.

<u>Section 4.</u> Section 10.04.030 of the Lebanon Municipal Code is hereby amended to read as follows:

"10.040.030. State Provision Amendments Adopted.

There are also incorporated by reference any Definitions, Sections or Provisions of Oregon Revised Statutes, including amendments, changes or substitutions enacted by the 1983 Oregon Legislature which reasonably apply to the Statutes incorporated in Section 10.040.020."

Section 5. It is necessary for the health, safety, comfort and convenience of the people of the City of Lebanon that this Ordinance take effect as soon as possible. Therefore, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect on October 15, 1983. Provided however, that those actions of the 1983 Oregon Legislature incorporated hereinabove which are effective prior to October 15, 1983 shall take effect as set forth in the Legislation.
