
THE CITY OF LEBANON ORDAINS AS FOLLOWS:

Section 1. Pursuant to Lebanon Municipal Code Chapter 8.24

Section 8.24.070, a public hearing was held as to the reasonableness of the attached Statement of Costs for mowing and weed abatement charges incurred by the City of Lebanon in 1983 and said Costs were found to be reasonable and do hereby become an obligation owed to the City by the owner of said property listed on the Statement of Costs attached hereto and made a part hereof.


