WHEREAS, the property described below in the Lebanon Rural Fire Protection District and the Grand Prairie Water Control District has been annexed to the City of Lebanon; and

WHEREAS, as provided in ORS 222.524, the Council has determined that the withdrawl of said property from said Districts is for the best interest of the City of Lebanon, now therefore,

THE CITY OF LEBANON ORDAINS AS FOLLOWS:

<u>Section 1.</u> The following described property is hereby withdrawn from the Lebanon Rural Fire Protection District and the Grand Prairie Water Control District:

Annexing Ordinance #1936 passed July 11, 1984:

Beginning at a 5/8 inch iron rod which is South 495.74 feet and South 45°31'00" West 2002.50 feet from the northeast corner of the James Ridgeway Donation Land Claim No. 46 in Township 12 South and Range 2 West of the Willamette Meridian in Linn County, Oregon, said rod also being on the northerly right-of-way of the Southern Pacific Railroad; and running thence North 44°36'38" West a distance of 235.88 feet to the easterly right-of-way of Market Road No: 24; thence southwesterly along a 1607.02 foot radius curve left (the long chord of which bears South 21°10'55" West 17.68 feet) a distance of 17.68 feet; thence South 20°52'00" West 374.83 feet; thence southwesterly along a 1402.40 foot radius curve left (the long chord of which bears South 17°40'51" West 155.88 feet) a distance of 155.96 feet to said northerly right-of-way; thence North 45°27'22" East 495.15 feet to the true point of beginning.
