WHEREAS, the property described below in the Lebanon Rural Fire Protection District and the Grand Prairie Water Control District has been annexed to the City of Lebanon; and

WHEREAS, as provided in ORS 222.524, the Council has determined that the withdrawl of said property from said Districts is for the best interest of the City of Lebanon, now therefore:

THE CITY OF LEBANON ORDAINS AS FOLLOWS:

Section 1. The following described properties are hereby withdrawn from the Lebanon Rural Fire Protection District and the Grand Prairie Water Control District:

<u>Section 2.</u> The City Recorder is hereby directed to make and submit a copy of this Ordinance to the appropriate state and county officials.

Section 3. Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the people of the City of Lebanon, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
